

Application For Water Connection to the Municipality of Scipio Town, Utah

I hereby apply to the municipality of Scipio for permission to connect my premises at _____ with the town of Scipio water system and hereby agree as follows:

1. A. The municipality shall make the requested connection from its water main to and including the water meter and up to my property line or to the meter if the meter is installed within my property. I agree to pay the municipality the connection charges and fees as may be fixed by the governing body by resolution or ordinance including a reservoir charge, if so provided.

B. Additionally, I agree to pay \$_____ for inspection and overhead charges and other miscellaneous charges of the municipality as may be fixed by the governing body by resolution or ordinance.

C. The work of extending the water connection from the point to which the municipality installs it, to the place at which the meter is to be used, shall be my responsibility and shall be performed at my sole cost.

D. The location of the meter, whether on my premises or at some point near my premises, may be decided solely by the municipality.
2. Before making connection with the water system, I shall cause the plumbing upon my premises to be inspected by the municipality and if the plumbing is not approved, I will cause the plumbing to be rectified at my own expense to meet the requirements of the municipality or of any other governmental agency having jurisdiction or regulate the water system within the municipality.
3. In the event of a failure to pay water charges within the due dates fixed by the governing body, or of a failure of the occupant of the premises to conform to the ordinances and regulations established by the governing body regulating the use of the water system, that the municipality shall have the right to discontinue the water system service at its election, pursuant to five (5) days written notice of the municipality's intention, until all delinquencies and any reconnection fees imposed are paid in full, or until any failure to conform to this ordinance or regulations issued there under is eliminated.
4. I will be bound by the rules, regulations, resolutions, or ordinances enacted now or hereafter by the municipality applicable to the municipality's water system.
5. The main purpose for which the water connection will be used is: **Culinary**
6. The municipality shall have free access to the lines and meters installed under this agreement and, at reasonable times, through my property if necessary.

7. Hookup after the new system is installed will have a one-thousand-dollar **(\$1,000.00)** connection fee.
8. I agree to pay an impact fee as set by Scipio Town of **\$3,096.00** before meter is installed.
9. I agree to pay twenty-seven (\$27.00) a month for this hook up whether I use it or not, or until a rate change is made by the Town Council.
10. I agree to pay a deposit fee of **\$86.00**. After 1 year, if water account is current the deposit will be credited to me. If water account is closed the deposit will be refunded.
11. I understand that at the present time the municipality is allowing me sixty thousand (60,000) gallons of water per quarter, and for any amount over this I will be charged according to the current posted fee schedule.
12. If collection is made by suit, or otherwise, I agree to pay all collection costs including reasonable attorney's fees.
13. If meter is shut off for non-payment, then the reconnection fee is \$75.00.
If meter is shut off by owner and locked, after **1 month**, the fee will be **\$350.00**.
