- 1. **Minutes of June Meeting:** Minutes were read aloud by Rebecca. Casey made a motion to accept the minutes, 2nd by Bryce. All in favor.
- 2. **Invoices and Receipts -June:** Linda went over these and gave copies to council. Jim made a motion, 2nd by Bryce. All in favor.
- 3. **Boys State Report- Rider Monroe:** He reported that he learned the responsibility's for being an American citizen. He ran for senator but did not get it. He received a scholarship to Weber state. He thanked the town for their sponsorship.
- 4. **Alan Cutler:** Alan with Hometown Ranches has an 8-acre farm on the north end of town by UDOT. He introduced his attorney Paul Maxfield who came with him. He wants to clear up the boundaries of his property that has other property over hanging on it with the existing fence lines and asked for a motion to be made and signed by the mayor saying the existing fence lines are the boundary. Bryce made a motion 2nd by Casey H. all in favor.
- 5. **Ambulance:** No one present
- 6. **Fire department:** Kevin Monroe reported from the district that the fire district has been approached by a solar company looking for a P.I.B. They do not want to pay 100% tax rate but they will pay a large amount but not all. They are looking for a 50% break. It is on the agenda for next month with the district meeting. Kevin will email council members the breakdown the location of the site is north west of IPP.
- 7. **Water & Ensign Engineering:** Kurt reported that the Parks improvement projects has been through HUD an environmental review and it has been put in the paper for 2 weeks for a bid. Aug. 2nd is the bid opening date. Pre bid on July 26th at 11:00 am on site with anyone interested.
- 8. **Streets/Fitness Center:** Rasmussen's came and did the road work. Gail has been mowing the streets.
- 9. **Parks & Cemetery:** Amy Barry came and did a class on straitening the head stones and taught how to wash and care for them.
- 10. **Events & Museum:** Casey reported that there will be 2 bounce houses for the games on the 22nd celebrations. On the 21st will be the town dinner at 6 pm. There will be a corn hole tournament going on that night and will finish that night. The town will pay for the meat at the dinner. The county decreased its donation to the towns for that from \$700 to \$550. The fridge in the museum died and they would like to buy a basic fridge to put in there.
- 11. **Public Comment**: Casey Draper asked a question- who owns the pavilion by the church? Town or the church. The town owns it, and he had a siding guy come look at the sofit that is broken or missing and since its so old it may all need to be replaced. He gave a bid of \$7,800 to repair it all. Tom mentioned that dogs are not allowed in the community center and fire district meeting will be held on Aug. 16th at community center.
