Minutes of Meeting

October 19th, 2023- 7pm

Members present: Mayor: Tom Memmott- Council Members; Casey Hatch, Jim Winget, (Bryce Monroe, Richard Probert Absent). **Also Present:** Clerk- Rebecca Bond, (Treasurer- Linda Stephenson- absent)

Prayer & Pledge: Juliana Probert offered the prayer; the Pledge of Allegiance was led by Jim Winget

1. **Minutes of October Meeting:** Minutes were read aloud by Rebecca. Casey made a motion to accept the minutes, 2nd by Jim. All in favor.
2. **Invoices and Receipts -October:** Linda absent-tabled until November
3. **Jess Peterson- 6 counties:** He is our new rep from 6 counties. They can help with writing policies, ordinances, applications, and other stuff. He is happy to start helping anytime.
4. **Alan Cutler:** Subdivision was approved to his HOA (home owners association) Home town Ranches. He plans to put 3 water meters in first.
5. **Ambulance:** No one present
6. **Fire department:** Casey reported that the fire prevention night went well. They will be registering for winter fire school -it will cost \$1,800. Got the lift motor for the garage doors at the fire house. Need updated electrical, better lights and to be maintained. Want to know responsibilities with council and fire dept and ambulance for keeping the building updated and maintained. O & M money can help with new doors and locks at fire station, electronic locks, and may need a new door- look into dead bolt. Made a motion to pay bills by Casey, 2nd by Jim, all in favor.
7. **Ensign Engineering:** Kurt reported that McKay with Provident Builders is working on getting his UEI number still and we can push the parks improvement project to spring if we cannot get to it soon enough because of the cold weather.
8. **Water- Richard:** Tabled
9. **Streets/Fitness Center:** Follow up on the cleanup with the street right of way clearing. If they have not done anything by the end of Nov. will send a notice and if not removed will remove and send a bill. UDOT road signs on the main street- we want to leave the driver feedback sign where it is and put in a solar one closer to the south. UDOT is looking into the cost of those.
10. **Parks & Cemetery:** Jim reported that they worked on the gopher problem and Jim sent in the bill. Amy B. took the headstone to fix it. Jim will make a base to put it on. Got a bid for trimming the trees from Pennys at the Sorenson Park and it was \$1,100 for each tree. Will look into another company for a bid.
11. **Events & Museum:** Casey reported that Halloween dinner will be at the church at 6:30 and we will do regular trick or treating. Museum is doing good.
12. **Resolution:** Have a resolution to cancel our election due to no one running- it passed- it was signed by Tom and Rebecca and will be posted.
