## Minutes of Meeting

November 21st, 2024-7pm

Prayer & Pledge: Casey D. offered the prayer; the Pledge of Allegiance was led by Tom

1. **Minutes of October Meeting:** Council looked over minutes. Jed made a motion to accept the minutes, 2nd by Bryce. All in favor.
2. **Invoices and Receipts** -October- Linda went over these. Council had a copy to look at. Water bills paid online in Xpress bill pay will not show until November Richard made a motion to accept, 2nd by Jed. All in favor. Audit will be December 11<sup>th</sup>

4. **Ambulance:** no one
5. **Fire department:** Casey Draper reported that we need a DNR contact and Nelson Brown said he could help with this. December 2<sup>nd</sup> is winter fire School. 2024 capital purchases were a Milwaukee tool set, battery operated tools, and a phone dispenser. Need to make an adjustment to the town ordinance for fire chief. 2019 article 3 – end of year we need to renew this. Also, at the district meeting he needs to resign the cooperate wildlife. Council is good with this.
6. **Ensign:** Kelly Chappell mentioned the drainage improvements project in town. UDOT did a study on 200 N to 200 S. There are a few options for funding. UDOT may be able to help and there is CIB. We could do it in phases to help with funding. Highest priority is 100 S. to 300 W. Our CIB priority list is first Cellular read water meters. Lead and copper report was approved. We need to send letters to those who are unknown about what type of pipes they have and update this.
7. **Assessment survey-** Hazard mitigation plan update- need everyone to look over this.
8. **Water Department:** Richard reported that the water tested good this month.
9. **Streets/Fitness Center:** Austin (Round Valley Ag) has done some repairs on equipment. Talked to Rasmussen's about doing crack sealing and some shoulder work. They will come over and check it out. Need to replace the light above the fitness center door that is flashing.
10. **Parks & Cemetery:** Jed reported he got the sprinklers in the park by the church winterized. Asked about the Sorenson Park.
11. **Events & Museum:** Kasey helped get the heat on at the museum
12. **Christmas Lights Contest:** Judging will be on the 17<sup>th</sup> and 18<sup>th</sup> of December
13. **Memory Tree Lighting:** This will be held December 2<sup>nd</sup> at 6:00 pm
14. **Mayor:** Water rate increase, want to have a public meeting to get public input on this. We need to raise the rates and want to do a yearly 3% increase.
