## Minutes of Meeting

December 19th, 2024-7pm

1. **Minutes of November Meeting:** Council looked over minutes. Kasey made a motion to accept the minutes, 2nd by Bryce. All in favor.
2. **Invoices and Receipts** -November- Linda went over these. Council had a copy to look at. Richard made a motion to accept, 2nd by Bryce. All in favor.
3. **Fee Schedule-** Linda gave a copy of the fee schedule to council to look over and change anything if needed. We will post it and if any changes need to be made, we will have a public hearing. Also reported that the audit went well.
4. **Planning and Zoning:** Cathy reported that they had the new subdivision ordinance ready and asked if the town would like to adopt this new ordinance to have something in place so we do not have to keep the states ordinance at this time and if we see changes needed, we could do it in the proper manner. 7. **Fire department:** Casey Draper reported they balanced the budget with county. Can get capital purchases Jan 1. Structure truck has been repaired by round valley ag. In January they will have a business meeting- structure of organization, chief and assistant chief.

9. **Water Department:** Richard reported that the water tested good this month. Will do a lead and copper test in the spring.

11. **Parks & Cemetery:** Jed reported he will get the gopher baiting done. Theres a grant opens Feb 1 to May 31, it's a small maintenance grant if we are interested.
