

Scipio Town Council

Meeting Minutes

October 16, 2025

Council Members Present:

Tom Memmott (Mayor), Richard Probert, Bryce Monroe, Jed Wasden, Kasey Brunson Also Present: Linda Stephenson (Treasurer), Rebecca Bond (Clerk).

1. Call to Order / Prayer / Pledge

Mayor Memmott called the meeting to order.

Prayer was offered by Jed.

Pledge of Allegiance was led by Bryce.

2. Approval of Minutes

The minutes from the previous meeting were read aloud by Rebecca. Kasey made a motion to approve the minutes, seconded by Bryce. All in favor.

3. Invoices & Receipts

Linda presented the invoices and receipts. Council members received copies to review. Richard made a motion to approve the invoices and receipts.

Seconded by Jed. All in favor.

Linda also read and reviewed the audit actions. There were two instances of late posting of the agenda, requiring a correction plan.

Additionally, the Impact Fee Report was rejected. Items included the well loan and water line repairs.

4. Ambulance

No ambulance personnel were present.

But a Public Comment:

Barry Monroe commented that about 90% of ambulance runs occur on the freeway. He asked whether businesses could be taxed or assessed for emergency services to help offset costs.

5. Fire Department

Casey Draper reported on the Millard County Community Wildfire Council.

They are increasing communication and looking for ways to mitigate fires and improve community relationships. There will be a meeting on December 2 in Fillmore.

The Fire House roof covering is complete. Residents are asked to notify the Sheriff's Office or Casey Draper before burning so they are aware it is a controlled burn.

Winter Fire School registration due by November 3, Casey asked if the town could help cover the cost since the fire budget is slim this year.

6. Water Department

Richard reported that the recent water tests came back good.

Testing included:

- Coliform
- Salmonella
- Nitrates
- Lead and copper
- Radiological tests
- Pesticides and additional contaminants

The same set of tests is required every three years.

7. Streets & Fitness Center

Bryce reported he met with Soloman regarding gravel pricing and it is charged by the ton. He also met with Kevin Rasmussen, they came and looked at the road repair needs including 300 W and 300 South, noting serious deterioration and low spots. Rasmussen will prepare bids. Also noted that the signs by the culvert at 300 E / 200 S were knocked over and need replacement to warn about the ditch.

Fitness Center:

Talked about the possibility of purchasing new equipment such as a stepper, rower, or assault bike. Also, cameras may be needed due to the game room and gym repeatedly being left messy and having things broken.

8. Parks & Cemetery

Jed reported all water systems have been winterized.

Casey asked about another phase of reseeding, and if council was wanting to do more noting it was costly. This will be reviewed and discussed next month. Work on the area could begin in March, depending on need.

9. Museum

Kacey reported the museum roof is finished and looks good.

10. Cyber Center

Rebecca reported that the .gov domains have been submitted and asked if council was ok for her to continue with the Cyber Center services they offer. Council was in agreeance.

11. Mayor Business

Tom reported that he sprayed for goat heads around town and will roto root at the spring again next month.

12. American Legion Post 61 – Donation

The mayor asked if the council was ok to donate again this year.

Council agreed to give a donation to American Legion Post 61.

13. Public Comment

George and Lisa Lanier reported that the Scipio General Plan has been revised but still needs corrections and edits. They asked where the document can be edited. Rebecca will try to find out.

14. Adjournment

Kasey made a motion to adjourn, Seconded by Bryce, All in favor.
