A Meeting of the Day County Leader's Association was held Tuesday, July 12, 2022 at the Day County Fairgrounds following the Livestock Committee meeting. President Duerre called the meeting to order. Flag pledges were recited.

Day County Fair Board: Access to barns - Harvey will reach out to Ben. The barns will be unlocked. Utilize the south entrance by the church as the Pavilion is being used that weekend. Cleaning – all buildings will be cleaned we are able to be look and assign clubs. Rat poison will be picked up by Fair Board as they placed it and would know where it was placed. Water project – Fair Board gave their idea of going around the outside as they don't want to tear up the middle. They discussed putting in a hydrant by the swine barn that could be done this year so Jim wouldn't need to bring in his pump. Infrastructure is the commissioners and Fair Board requested to go jointly to the County and ask the Commission for \$10,000, 4-H could pay \$10,000, and the Fair Board would pay the remainder. Project would be completed after Pumpkin Fest. Commissioner Walter questioned the quote given from April 24th being out of County and they have already approved Duerre Excavation's plan to trench. Discussion on the project going back to the County Commission, as it's County property and it's up to them to decide. Fair Board said that we could go back jointly and ask them to rescind their original motion if we wanted to change the proposal. Discussion was held on pressure pump, current water, and covered show ring. Bathroom – discussion on passing inspection, ceiling being sealed, weight of doors, ventilation, stoppers on the doors, and what is the process to transfer.

The Secretary's Report was attached to the agenda. Thad Duerre made a motion to approve the minutes from the Leaders Association meetings held May 26, 2022 and June 6, 2022, seconded by Amy Fischer. All members voting in favor. Motion carried.

The Treasurer's report was given by Jill Gaikowski. General Fund - \$6,027.56, Money Market - \$5,650.45, Livestock Account - \$10,809.97. A motion was made by Cindy Weyh to approve the Treasurer's report, seconded by Traci Ellingson. All members voting in favor. Motion carried.
