Motion by Amy Fischer to approve the **Agenda**. Sam Hubsch second. Motion carried.

Secretary's report (Robin Dorsett): Motion by Josh Atherton to approve the November 2024 Secretary's report. Brandon Zubke Second. Motion carried. Correspondence: Thank you note from a 4Her. 3 blank thank you notes presented for present Leaders to sign.

Treasurer's report (Amy Fischer):

- Misty Hemmingson motioned to approve the claims as presented and to approve the Treasurer's Report. Brandon second. Discussion: *Balances:* Leaders (\$5,501.58), Money Market (\$10,137.99), *Earmarked funds* to deduct from total funds: Animal Clinics (\$1,523.19), Bike Rodeo (2828.00). Cash available: \$11,288.38. Motion carried.
- Brandon motioned to give a \$20 GC to Andy and Kara Paulson. Jessica McGregor second.
 Discussion: A late Courthouse Christmas donation was turned in and a Leader offered the Paulson family as a suggestion since they are dealing with health issues at this time and we (Leaders Assoc.) would like to offer some help to them. Motion carried.

The idea is to let kids choose from a "Mall" of awards. The Mall has three levels of awards. Members earn the ability to choose an award by, for example, winning Best of Show, Grand Champion Showmanship, Judges Choice, YIA participant, just to name a few. This Mall idea is still in the works and we would like input and ideas from all ages of 4-H members. Please ask your members, at your next club meeting, what kinds of prizes they would like to choose from. Increasing the number of awards will also increase the amount of money needed. The committee is asking for a \$15,650 budget. This request was figured at the top end of everything. Top end, meaning, the max amount of awards that could be given in all areas. It should also be noted that no money will be spent this year on CWF. Misty motioned to approve the Awards Committee Budget request. Brandon second. With no further discussion, motion carried.
