Role Profile: Football Safeguarding Officer

Job Title: Area Safeguarding Officer

Responsible to: FAW Safeguarding Team

Role Purpose

To promote and ensure the safety, welfare, and wellbeing of children, young people, and adults at risk within football. The Safeguarding Officer acts as the first point of contact for all safeguarding concerns, ensures compliance with safeguarding regulations, and works with coaches, staff, volunteers, and external agencies to create a safe and positive football environment.

Area Safeguarding Officer Roles and Responsibilities

- Act as the association's Lead Safeguarding Officer, liaising with member league and club safeguarding officers.
- Promote and disseminate FAW Safeguarding policies and procedures.
- Manage children's welfare within the Association.
- Arrange and attend necessary meetings with member leagues and clubs.
- Assist FAW Safeguarding department with investigations into safeguarding concerns where directed.
- Investigate safeguarding issues and complaints where appropriate.
- Report issues to FAW Safeguarding that cannot be dealt with at an Area level.
- Monitor best practice at club and league level.
- Ensure that the necessary training is provided
- Manage the Area's responsibility to safeguard children & vulnerable persons.
- Build and maintain a proactive safeguarding culture.
