
AMENDED FINAL JUDGMENT

In accordance with the court's memorandum opinion and order granting summary judgment in plaintiff Jose Alfaro's favor on March 14, 2019 (Dkt. 21), its memorandum opinion and order awarding damages on April 24, 2019, and its order awarding attorneys' fees signed on this date, judgment is ENTERED in Alfaro's favor against defendant Jason Daniel Gandy as follows:

- (1) Alfaro is AWARDED \$1,436,409.00 in compensatory and punitive damages;
- (2) Alfaro is AWARDED \$75,350.00 in attorneys' fees; and
- (3) Alfaro is AWARDED post-judgment interest on all sums awarded pursuant to 28 U.S.C. § 1961 at a rate of 2.28%. Post-judgment interest is to be calculated daily and compounded annually from the date of this judgment until paid.
