## ASSESSMENT AND CART FEES

### Assessment Dues

In 2021 the Assessment fee will increase slightly to \$175 so we can continue to make valuable improvements to the course. This fee is not applicable for Student's or League only membership and is already built into Social memberships.

#### Payment Options:

- \$175 enclosed
  - Charge my credit card for \$175
  - I will be adding \$14.60 per month to my dues installment payment.

### Cart Leases

In 2021 we will continue to offer various cart leases. This fee is due by May 1, 2021.

#### Payment Options:

- \$700 for Private Cart Lease(not subject to sales tax). *Private cart owners must provide proof of liability insurance naming Sherrill-Kenwood Golf Club, LLC and the Oneida Community Mansion House as additional insured (minimum of \$300,000).*
  - \$648 for GOLD – Single Cart Lease (sales tax included -- \$600 cart Fee + \$48 for sales tax)
  - \$918 for PLATINUM – Two-Person Household Cart Lease (sales tax included -- \$850 cart Fee + \$68 for sales tax)
  - \$405 for SILVER – 60 rounds of 9 holes (sales tax included -- \$375 cart Fee + \$30 for sales tax)
  - \$216 for BRONZE – 30 rounds of 9 holes (sales tax included -- \$200 cart fee + \$16 for sales tax)
