### INTERVIEW WITH A PROFESSIONAL PARLIAMENTARIAN

#### Daniel Seabold, Ph.D., PRP

#### **Biographical Questions**

- Q. As a kid, what were you like?
- A. Relatively quiet and well-behaved. I had plenty of friends at school, in the neighborhood, and at church. I played baseball and soccer, read a good bit, and spent a lot of time in the woods.
- Q. When your friends/family find out that you are a professional parliamentarian what do they say or ask?
- A. Occasionally a colleague at the university where I work will discover my involvement with RONR. They are often (happily) surprised and ask how I got involved with it. I also get a fair number of questions from colleagues about procedure.
- Q. How would (someone) describe you?
- A. I shudder to think.
- Q. What might (someone) be surprised to know about you?
- A. That I am the Acting Dean of the College of Liberal Arts and Sciences at Hofstra University.
- Q. What do you do when you aren't involved with Parliamentary Procedure?
- A. I have a daughter and two sons. If you had asked me this question a few years ago, I would have said that I spent most of my free time driving them to and from dance and karate lessons and soccer practice. But they are getting older now and have started to disperse into the world. My dog Sadie has taken up some of that time. I still read a fair amount, though much less than I did a decade ago, when I was working through the classics from Homer and Herodotus to Milton. Also, I waste a lot of time on genealogy.

#### Parliamentary life

- Q. Tell me how you first got involved in with Parliamentary procedure?
- A. I was elected(!) to serve as parliamentarian to the faculty at Hofstra University, a post for which I was about as wellqualified as Henry Robert was to preside over the infamous 1863 meeting related to the defense of New Bedford from Confederate attack. Like Mr. Robert, I decided that I had some learning to do.
- Q. What has surprised you most about working with other Parliamentarians?
- A. How seriously they take parliamentary procedure.
- Q. What would you tell someone who is thinking about becoming a RP / PRP?
- A. If you are a bookish sort, but also somewhat civically-engaged, parliamentary procedure is a great hobby that can do good both for yourself and for others.

- Q. What (if any) specific advice or recommendations does he have for youth parliamentarians?
- A. Keep up on your training. Many kids take up hobbies that they abandon in later life, but a knowledge of parliamentary procedure can certainly be a lifetime pursuit. Fly-fishing is another option.
- Q. The interest in RONR seems to be growing. Why do you think that is?
- A. I hadn't noticed that interest was growing. That's good news, if true. I think that one of the greatest threats to parliamentary procedure is the tendency of boards to take control of organizations from members who lack a basic knowledge of procedure. I still like the idea of equals gathered together in a room—not as appointed leaders, but as ordinary members—choosing a course of action after mutual debate.
- Q. What do you wish other people knew about Parliamentary Procedure?
- A. That its purpose is to make meetings run fairly and efficiently, not to impede business with fussy rules nor to confer tactical advantage on the cognoscenti.
- Q. What would you say are some of your strongest beliefs about Parliamentary Procedure?
- A. An old story circulates that Wolfgang Pauli, a theoretical physicist, was challenged during lecture for claiming that something was obvious. "I'm sorry professor," a student insisted, "but I don't think that is obvious at all." Pauli stared at the board, stared at the student, and paced the room a bit. He then went to his office where he sat, deep in thought, for half an hour. He then returned to class, saying "No, it's definitely obvious."

#### That is exactly how I feel about most of parliamentary procedure.

- Q. If you could change one thing about Parliamentary Procedure, what would it be?
- A. I think it's (obviously) perfect just the way it is.
- Q. What do you think will change about parliamentary procedure over the next five years?
- A. Even after the pandemic recedes, I expect to see a permanent increase in the number of meetings conducted online. When authorized by the bylaws, something very like a traditional meeting can be conducted via Zoom for a dozen people. But it's not clear that most convention-scale electronic meetings can even be considered meetings of a deliberative assembly. The next time you are in an online meeting, ask yourself this question: If I observe a breach of the rules, can I call the attention of the members and the chair to it without first getting someone's permission to speak?
- Q. As a parliamentarian what is the most challenging responsibility / job you have ever taken?
- A. Editing RONR. And there isn't a close second.

## INTERVIEW WITH A PROFESSIONAL PARLIAMENTARIAN

#### Specific to RONR

- Q. How did you get involved with editing RONR?
- A. In 2006, I was asked to speak at the "Advanced Seminar" organized by the Robert's Rules Association. After I spoke, Dan Honemann invited me to interview at his law offices for a position on the authorship team.
- Q. What is your favorite and least favorite motion and why?
- A. My favorite is the motion to create a proviso and my least favorite is probably the motion to go into quasi-committee of the whole.
- Q. What do you find most challenging about UPDATING RONR 12th edition?
- A. Sitting in a room for eight hours, debating, amending, and voting on complex proposals is actually quite grueling.
- Q. Does the responsibility come with a lot of pressure due to the notoriety of RONR?
- A. Like the doctors say, "First, do no harm". Knowing that the book has worked fine for millions of people for many years just as it is, that any particular change may cause inadvertent harm, and that any unwise edits will remain in place for ten years is a lot of pressure.
- Q. Tell me about someone who has influenced your decision to work on updating RONR?
- A. They asked, and I said yes. There was never any hesitancy on my part to accept the position. It's an honor.
- Q. What's the best/worst thing to happen since you started working with RONR?
- A. The best thing has undoubtedly been to meet and work closely with Henry, Dan, Burke, and Shmuel. The worst is being unable to go to the grocery store without being mobbed by parliamentary groupies and paparazzi.


