Sessions are done via the Internet through live video streaming using ZOOM technology.

For your event, *Worldview Matters*® will provide:

1. 6 total hours of instruction by Dr. Christian Overman presented in three 2-hour sessions done over a period of 3 days. These days may be consecutive, or they may be spread over whatever period of time determined by the hosting organization, within a maximum time-frame of 3 months.
2. Participants attending all 6 hours will receive 1 CEU as recognized by the Association of Christian Schools International (ACSI).
3. 1 full-color, 48-page hard-copy Participant Guide for each attendee.
4. 2 books for each attendee (*Assumptions That Affect Our Lives*, and *The Lost Purpose for Learning*), designed for follow-up staff discussion following the training.
5. Handouts for all sessions.

The Hosting Organization will:

1. Provide a meeting room in which participants are (preferably) seated at desks or tables (for ease of writing).
2. Provide a large screen or LCD projector connected to a computer for ease of viewing by all participants (even from the back row).
3. Make copies of various handouts for all participants provided by Dr. Overman via e-mail at least 1 day prior to the event.

Fees:

TOPICS ADDRESSED IN THE “GOD’S PLEASURE AT WORK” WORKSHOP

Session 1 (first 2-hour segment):

Title: “How to Connect Any Subject (at any grade level) with the Bigger Picture of a Biblical Worldview”

Content: How connecting subject matter to the biblical worldview makes Christian education authentically Christian. An introduction to the “Conversation Starter” and “Activities Contextualizer” lesson plan tools.

Session 2 (second 2-hour segment):

Title: “The Lost Purpose for Learning”

Content: Why Christian schools should exist, what our purpose should be, and how we can rid ourselves of the “Sacred-Secular Divide.” An introduction to the “Awesome Activator” lesson plan tool.

Session 3 (final 2-hour segment):
