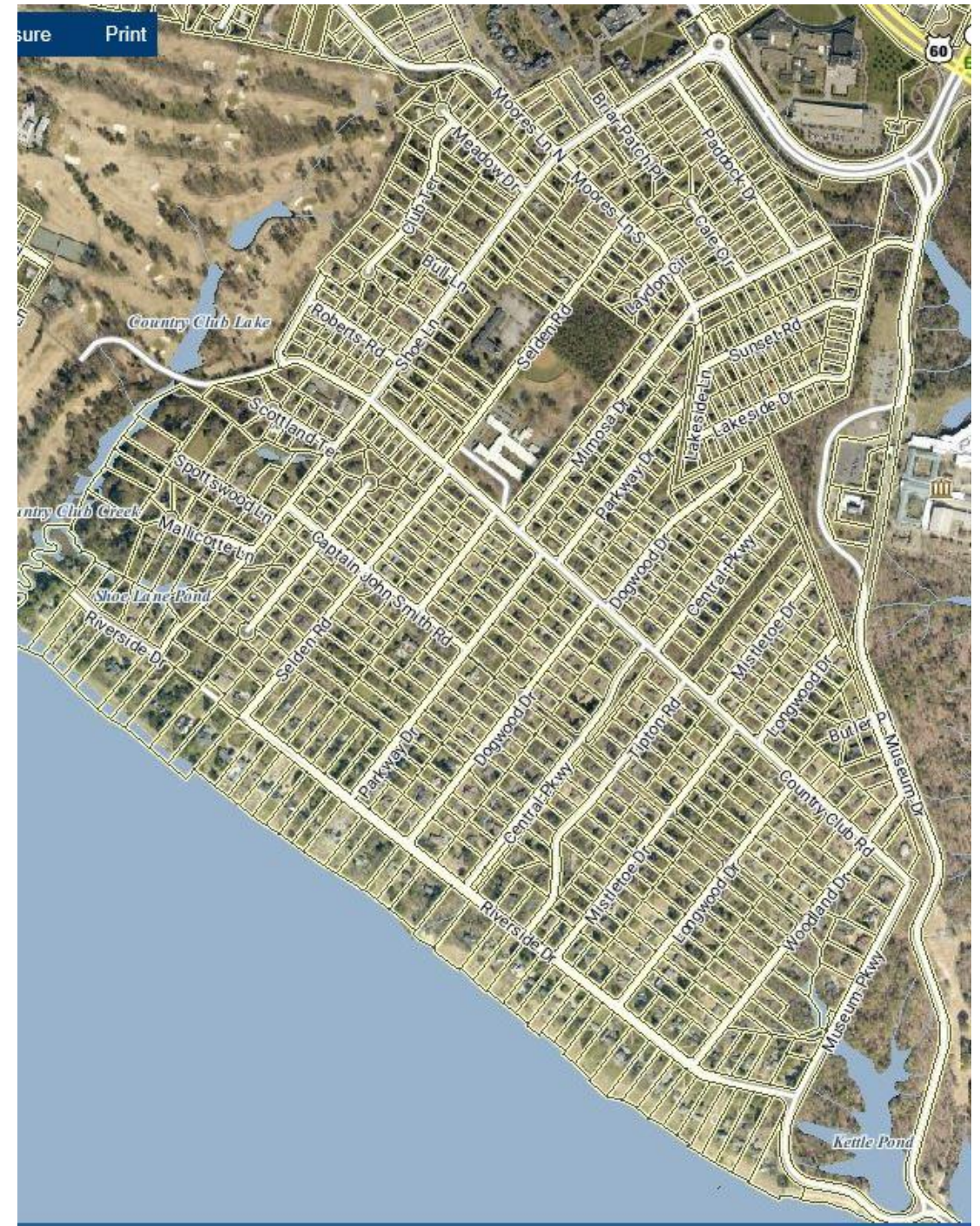

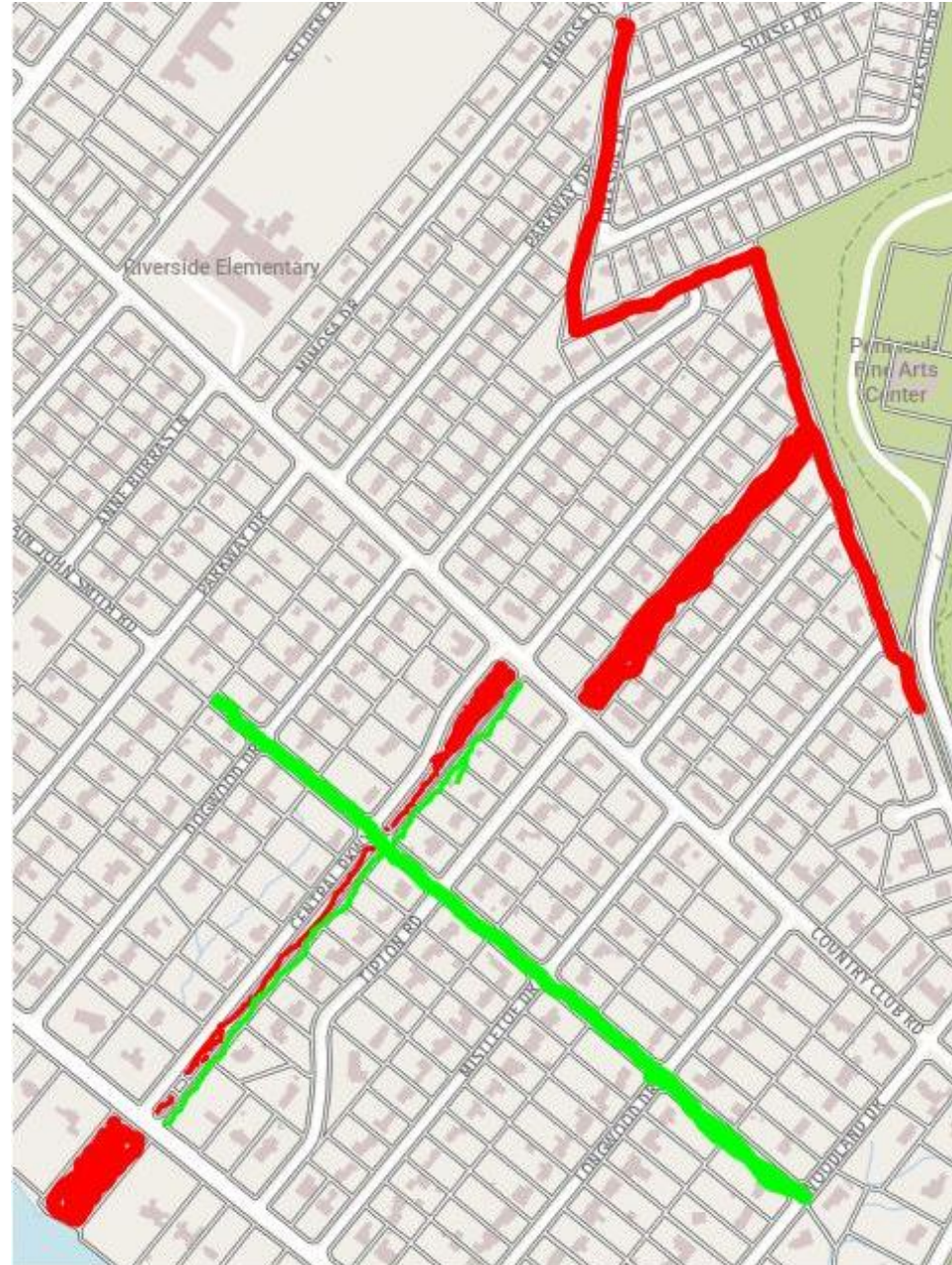

Traffic Calming Status Update:

THE RESIDENTIAL TRAFFIC CALMING PROGRAM

STEP BY STEP PROCESS

1. City receives a concern from a resident.
2. City sends resident a letter and information about the Traffic Calming Program.
3. City conducts preliminary investigation (Housing Density, Zoning, Posted Speed and Operating 85th Percentile Speed).
4. City sends resident a 2nd letter discussing the findings of the investigation. If not favorable, process stops here. If favorable, then the 2nd letter will contain the 1st petition (Petition Requesting Traffic Calming Evaluation).
5. City receives and verifies completed 1st Petition.
6. City conducts a Neighborhood Informational Meeting.
7. Residents form a Task Force (with City participation), prepare a Traffic Calming Master Plan for their block(s) and present the City with the 2nd Petition (Master Plan Support).
8. Master Plan is routed through the City Departments for Evaluation and Comment.
9. City modifies Master Plan based on comments and Master Plan is presented to the Task Force.
10. City implements Modified Master Plan on a temporary trial basis and a comment period is established for public comment.
11. City reviews public comments. If comments are severe, then the process reverts back to Step 9. If comments would not alter the Modified Master Plan, then the process continues.
12. City prepares a final report to the City Manager's Office with findings and final recommended course of action. City Manager may opt to forward report to City Council for their review and comment.
13. City implements course of action as approved/modified by the City Manager/City Council.



Martha's Way Update:



Road Closure Announcement 📣
Starting **Friday, January 9**, please be aware of the following temporary road closures. We anticipate a **month-long closure**, which will enable work on the next phase of the Martha's Way project, an initiative to improve the James River shoreline:

🚧 No through-traffic will be permitted from Museum Parkway onto Lions Bridge (see second picture). The portion of Museum Parkway that connects to Lions Bridge, in front of Kettle Pond, will be closed to all traffic.

🚧 Lions Bridge remains open during construction, and traffic can still enter the Museum entrance from the bridge

Short term rental rules Passed in June 2022. Enforcement began May 2025.



Key Requirements from the Ordinance

Who Can Host

- Must be your primary residence (185+ days/year)
- No detached structures allowed
- Up to 6 lodgers, max 2 per bedroom

Safety & Zoning Standards

- An exit plan is posted in every bedroom
- Smoke/CO detectors & fire extinguishers

Prohibited:

- Commercial gatherings (parties, weddings, fundraisers)
- Loud noise or code violations
- Multiple rentals at the same time

You Must Also

- Get a business license
- Maintain a guest log
- Pay the transient occupancy tax

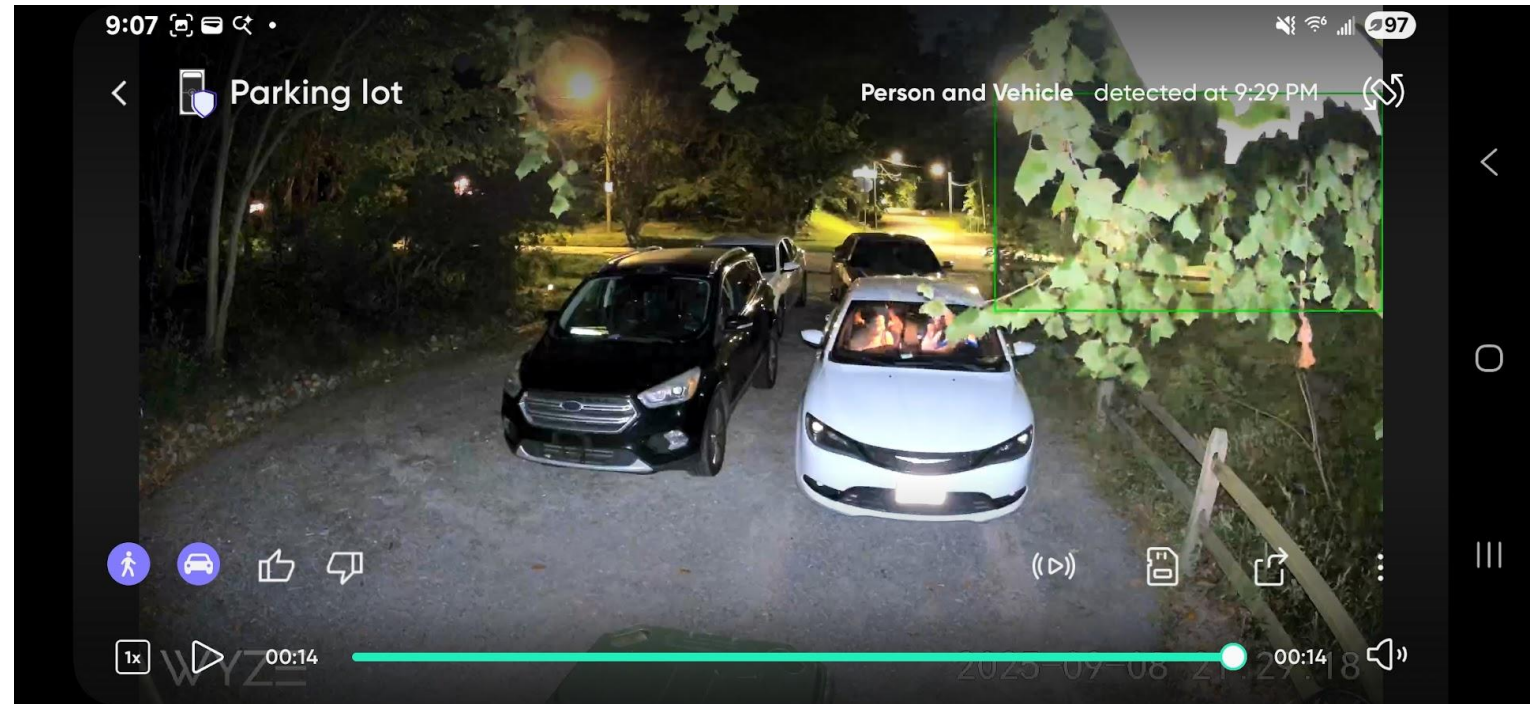
