South Carolina Concealed Weapons Permit course

The two parts of the course using a classroom may be held in the Fellowship Building of Gum Springs Pentecostal Holiness Church, 203 Gum Springs Rd, Taylors, SC 29687 (near Lake Robinson). *Time in class* is around 8 hours total. Other classroom venues and flexible times are feasible. Please inquire if interested. *6 students per class are ideal, and fewer are feasible.* More may be allowed in some circumstances.

SLED's CWP Firearms Proficiency Qualification Course of fire is often held at SharpShooters Indoor Range & Gun Club, 1345 Rutherford Rd, Greenville, SC 29609 (opposite Farmers Market). Total range time varies, since students now may need to qualify one at a time, and some will take longer than others. Please arrive no later than 10 minutes *before* start time at classroom & range.

Then go online & schedule your local digital fingerprinting (instructor will explain, no fee) when you will simultaneously submit your CWP application paperwork; no postage. For Greenville County, the Identogo location is 30 Orchard Park Dr, Suite 21, Greenville, SC 29615. Go to www.sled.sc.gov/, click on CWP Program section and follow the instructions. Complete your application paperwork by hand. **Just keep it clearly legible.** SLED requires legibility.

Once you successfully complete SC CWP training requirements, you have up to 3 years to submit your CWP application. You probably will want to apply soon.

Costs: \$50.00 SAFER, LLC - only check or cash \$15.75 SharpShooters - pay to range* \$65.75 (You may mail app to SLED. If so, add postage & include 2 completed ink fingerprint cards at your cost.)

Plus: your correct, factory boxed ammo, or buy ammo from SS if using their handgun. *Use of range, target, 1 free gun rental *option*, eye & ear protection. (Individual *manual/ink* fingerprinting at SS is \$10.) Bring your own or use SS's eye & ear protection; both are **required** to shoot.

Requirements include Firearm Safety & Operation and Legal Aspects (both in classroom) with 50 question written test, and the SLED CWP Proficiency Qualifying Course of Fire **as you carefully follow instructions** to shoot 25 rounds from 3-12 yards at a standard silhouette target. To apply to SLED for the CWP, students must make at least 70% correct on the written test and the shooting proficiency qualification. The test and shooting are not difficult. **If you have not fired a pistol before, you must let me know** well before class.

You must have a clean, non-crime and crime free record to obtain a CWP. SLED will conduct a thorough background check on each CWP applicant. Also, one must be at least 18 years old to submit a SC CWP app.

First, please email, text or call me for upcoming class times or questions. Front of brochure has contact info. *If you call, please leave a voice message.* I'll get back to you as soon as I'm able.

Then, complete a registration form (to right) and bring with you to class, or mail with your \$50 check to SAFER, LLC. Do NOT show up for a class without your course fee or having prepaid. **Please check your schedule carefully and decide this training is your priority before you commit to attend a class.** Thank you!

For class time, bring your state issued photo ID (usually your SC drivers license), your partly completed CWP application (optional), a note pad and pen. **Do not bring guns or ammo into classroom.** You may want to bring some dry snacks and water in closeable containers.

For range time qualifying, bring the handgun you plan to use (unless using a SS range rental gun at no extra charge), some kind of range bag or handgun case to secure & conceal gun between your car and the range shooting booth, 25 rounds of good factory ammo for the specific gun, in the manufacturer's box (if using rental gun, must buy ammo from SS), and, if you choose, your own *eye and ear protection*. Firearms must be in good condition, and will be inspected before live firing. No unsafe or illegal guns allowed. Be sure to bring photo ID to range.

The instructor reserves the right to refuse approval for any student's CWP application for any reason.

I appreciate your interest, and will try my reasonable best to help you obtain your SC CWP!
