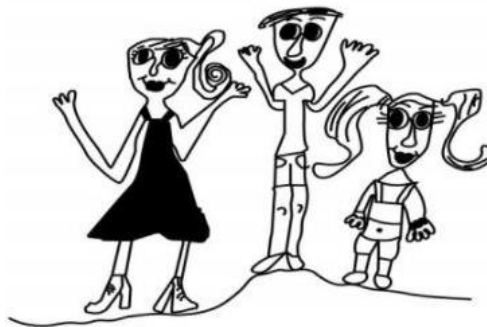

Fee Schedule

All clients (Private, Medicare and NDIS) will be charged the NDIS rate of \$193.99 per hour for services. Please see a more in depth break down of fees below:

Appointment Fees

Initial Consultation	45min Face to Face + 45min Administration	\$290.99
Assessment Session	45min Face to Face + 15min Administration	\$193.99
Private Therapy Session	30min Face to Face + 15min Administration	\$145.49
NDIS Therapy Session	10min Prep + 40min Session + 10min Admin	\$193.99

Assessment Fees

Pragmatic Language Assessment (including report and feedback)	\$775.00
Oral Language Assessment (including report and feedback)	\$775.00
Vineland Assessment (including forms, report and feedback)	\$387.00
Classroom Observation (includes travel, 45mins observation and feedback)	\$291.00
Oral Language + Pragmatic Language Assessment (including report and feedback)	\$1163.00

Fees can also apply for indirect tasks that are completed without the client present. These services are charged in 10 minute blocks. Please see examples of these kinds of services below:

Administration	1 hour	\$193.99
Report Writing	1 hour	\$193.99
Resource Preparation	1 hour	\$193.99
Communication with Other Professionals	1 hour	\$193.99
Travel (only when required)	Up to 30min	\$ 97.00

Payment must be made by direct bank deposit immediately upon being invoiced. Invoices will be sent via email to the email address you supply on your intake form.

Medicare Rebates

You may be eligible for a Medicare rebate of \$60.35 for up to 5 sessions per year if you access a Chronic Disease Management Program from your child's GP. An additional 5 appointments per year are available for people of Aboriginal and Torres Strait Islander descent. To utilize this program you must provide a copy of the CDMP to Ballarat Speech Pathology prior to your appointment.

A rebate may also be available to patients for the treatment of a diagnosed complex neurodevelopmental disorder (such as autism spectrum disorder) or eligible disability. This must be discussed with your GP and a management plan must be provided to Ballarat Speech Pathology before your appointment.

NDIS Plans

Your NDIS plan may cover speech therapy services, up to a certain amount. Ballarat Speech Pathology are able to claim NDIS payments for services under plans that are Plan Managed or Self Managed. A copy of your NDIS plan must be supplied to Ballarat Speech Pathology prior to your appointment. If your NDIS plan is plan managed, please supply this information to us along with your plan so that we can bill your plan manager directly.
