### **NEW BUSINESS REPORT:**

### CHAIR REPORT:

- 1. Kathy Kerney reported on the Annual Brunch that will be held on February 29, 2024. The theme is Leap into Spring. Each day will create two baskets with a cost between \$50.00 \$75.00. # Meeting Notes for 2/13/2024

# **Handicaps**

## Issues to be Addressed:

- Most of the disqualifications coming through have been for math errors from either one or both putters.
- 2) Remember that all parts of the card are to be correct. Be it under your name or your partner's name. (addition, net score, H/C etc.)
- 3) I am not getting a scorecard from one or both people putting. Both seem to be going to Birds if each putter had a hole in one. Therefore, nothing to check off if they putted or not if I see a disqualification next to their name.
- 4) Disqualification not being circled on Scorecard and reason for disqualification not being written on Money awards sheet. I document all disqualifications in case anyone needs to know if, when and the reason why a putter was disqualified.
- 5) Remember that if a putter is Disqualified, they still get paid for their holes in ones. They do not, however, get paid for their magic hole if they happen to get it.

# Membership
