## 2020-2021 Studio Policies

- 1. A \$30 non-refundable registration fee and signed copy of the studio rules must accompany the registration form to have your space reserved. There are absolutely no refunds on registration fees- no exceptions!
- 2. A Step of Class does not carry medical insurance for its students. All students must be covered by their own family insurance. Should an injury occur, the student's policy will be the only source of reimbursement.
- Leotards, tights, and appropriate dance shoes are required for all students. Boys should wear a t-shirt and dance pants. Proper shoes in specific colors are required. Please label all shoes with your child's name! ASOC is not responsible for lost or stolen items. NO STREET SHOES ON THE DANCE FLOOR!
- 4. Students should not be dropped off more than 10 minutes before class begins, and should be picked up no later than 10 minutes after class ends. Students should remain inside until their ride arrives.
- 5. No food, drinks, or gum will be allowed in any areas except the snack room.
- 6. No pets allowed in the studio.
- 7. Disruptive behavior will not be tolerated. If this occurs repeatedly, your child will be sent out of class and parents will be notified.
- Tuition is due the first of every month. A late fee of \$10 will be added to the account after the 10th of every month. Tuition is based on a yearly amount and divided into equal monthly payments from September through May. Tuition for August will be prorated. A \$30 service charge will be charged for all returned checks.
- 9. No student will be allowed to participate in class if their account is more than 30 days past due. Any money received on a delinquent account will first be applied to past due balances. No student will be allowed to participate in the recital unless their account is in good standing.
- 10. There will be no refunds for missed classes. Missed classes may be made up in an age appropriate class.
- 11. You must notify us in writing 30 days prior to your child withdrawing from a class. Not showing up does not constitute a withdrawal! You are responsible for all tuition up to the 30 days notice.
- 12. Once costumes are ordered, no refunds will be given under any circumstances.
- 13. All sessions are closed sessions. Please **do not** open the door during class time.
- 14. In the event of inclement weather, there will be a message on our website announcing any closures or cancellations, a group e-mail message will also be sent.


