



## 2023 Great Futures Raffle Rules

Boys & Girls Clubs of Hopkinsville-Christian County has been and remains an independent 501(c)(3) non-profit organization with EIN #20-2103260. Boys & Girls Clubs of Hopkinsville-Christian County is located and operates in Christian County, Kentucky. The prize drawings will be held on Friday, December 15, @ 10:00AM CST, at the Boys & Girls Clubs of Hopkinsville-Christian County, 1600 Walnut Street, Hopkinsville, KY and streaming LIVE on BGCHCC's Facebook social media feed ([facebook.com/hoptownbgc](https://www.facebook.com/hoptownbgc)). This date and all other dates stated in these rules may be extended at the absolute discretion of the Boys & Girls Clubs of Hopkinsville-Christian County. Tickets may sell out before that time. The winning ticket will be drawn at random from a hopper containing

names of all eligible raffle tickets by the chairperson(s) of the raffle. The winner does not need to be present or watching the live feed to win. The public will not be able to attend the drawing.

4. ELIGIBILITY: Raffle ticket purchasers and the person named on a raffle ticket must be at least 21 years of age at the time of purchase. Offer void to anyone under the age of 21.
