****Please note Happy Child Preschool charges a snack fee of \$5/month in addition to monthly tuition.***

Fees are due the 1st of the month, regardless of illness, vacation, or inclement weather. There will be a \$15.00 late fee for tuition paid after the 10th of the month. A \$25 fee will be charged for a returned check or credit card charge. **There is a discount option for annual tuition paid in full by September 15th: 6% off if paid by check; 3% off if paid by credit card.** A \$10 per month tuition discount will be given for the 2nd child in each family. Total discounts will not exceed 10% per family per year.

Full monthly tuition is charged for the class in which your child is registered ***regardless of the number of days per week you chose to send your student.*** (i.e., if you register for a 4-day class but elect to send your child 3-days per week, you will be charged for the 4-day/week monthly tuition).

Tuition paid is non-refundable. There are no discounts granted for inclement weather or other unforeseen circumstances, absences, or vacations.

A non-refundable \$50.00 registration fee is due with application (\$25.00 for second child). Your first month's tuition is due NO LATER than **June 1st (this is September's tuition payment).** Your next invoice will be sent October 1st. If you register your child after June 1st, the registration fee and the first month's tuition is due upon receipt of application.
