^{*}Please note Happy Child Preschool charges a snack fee of \$5/month in addition to monthly tuition.

Fees are due the 1st of the month, regardless of illness, vacation, or inclement weather. There will be a \$15.00 late fee for tuition paid after the 15th of the month. A \$25 fee will be charged for a returned check or credit card charge. There is a discount option for annual tuition paid in full by September 15th: 7% off if paid by check; 4% off if paid by credit card. A \$10 per month tuition discount will be given for the 2nd child in each family. Total discounts will not exceed 10% per family per year.

Full monthly tuition is charged for the class in which your child is registered *regardless of the number of days per week you chose to send your student*. (i.e., if you register for a 4-day class but elect to send your child 3-days per week, you will be charged for the 4-day/week monthly tuition).

Tuition paid is non-refundable. There are no discounts granted for inclement weather or other unforeseen circumstances, absences, or vacations.

A non-refundable \$50.00 registration fee is due with application (\$25.00 for second child). Your first month's tuition is due NO LATER than **June 1**st (this is September's tuition payment). Your next invoice will be sent October 1st. If you register your child after June 1st, the registration fee and the first month's tuition is due upon receipt of application.
