INSTRUCTIONS

This is an application to allow the movement of a motor vehicle over certain portions of closed highways within Howe Township. The Applicant may make application for a vehicle owned by the Applicant or by one providing contracted services for the Applicant. If the Applicant intends to utilize more than one vehicle, a separate application must be completed with respect to each vehicle. At the time of submitting a new application, the Applicant shall pay the fee of \$50. (Any subsequent application submitted by the Applicant on that same date and for the exact same portion of roadways shall require only a \$5 fee per application.) Additional materials such as the signing of an Excess Maintenance Agreement or the posting of bond may be required by the Township.
