RAIL TRAIL ORDINANCE ADOPTION: A motion made by Summers and seconded by Shaffer was passed unanimously to adopt Ordinance 18-1 Rail Trail/Snowmobile Ordinance.

HIRING A FULL TIME ROAD WORKER/ROADMASTER GOES TO 40

HOURS: Supervisor Summers offered his opinion that things stay as is for the remainder of the year due to budget rules but suggested having a special meeting or an executive session to discuss all options and to discuss the direction all the supervisors want to see for the future of the township. This topic was tabled until the September or special meeting.

ROCKY RUN GRANT PROJECT: A motion made by Summers and seconded by Shaffer was passed unanimously to re-advertise for bids for the Rocky Run Grant project. This advertisement will reflect a new end date requirement. The secretary will check prices with the Oil City Derrick before advertising.

NEW BUSINESS:

SRS OVERPAYMENT: A motion made by Summers and seconded by Shaffer was passed unanimously to refund the overpayment of the Secure Rural Schools money to the Forest County Title III Forest Funds Account in the amount of \$15,352.13.

2019 BUDGET CALENDAR: The 2019 Budget Calendar was distributed to the supervisors to review along with the 2019 "wish list" of anticipated expenditures.
