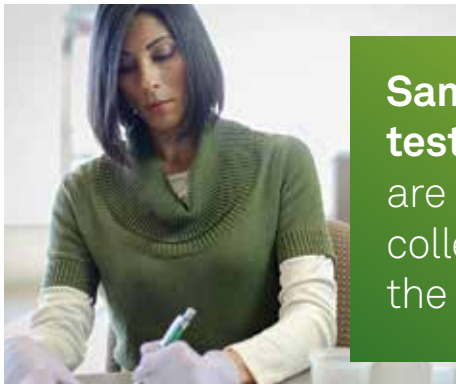

Testing documentation

To help reduce court costs and assist in ensuring the admissibility of testing records in disputed proceedings, Quest Diagnostics offers several test document options.

Business record affidavit

Designed specifically to reduce court costs and simplify the admissibility of test results as authenticated business records, an affidavit is typically available within two to three business days of request. This documentation is compliant with federal rules of evidence and includes the external custody and control form and the final laboratory report.

Comprehensive documentation package

Available within three to four weeks of request, a comprehensive documentation package demonstrates the laboratory's strict adherence to chain of custody procedures and provides all testing and quality control data, including both screening and confirmation testing.

Urine testing

Laboratory-based urine testing is the most common drug testing method, providing proven methodology and a broad range of testing panels. Online results are available immediately after the screen is complete, so you are not waiting for mail or faxes.

Instant testing

When answers are needed fast, we offer on-site drug and alcohol testing devices that can deliver results in minutes for up to 11 different analytes and/or drug classes. Confirmations on positive tests are typically available within 72 hours of receipt at the laboratory.

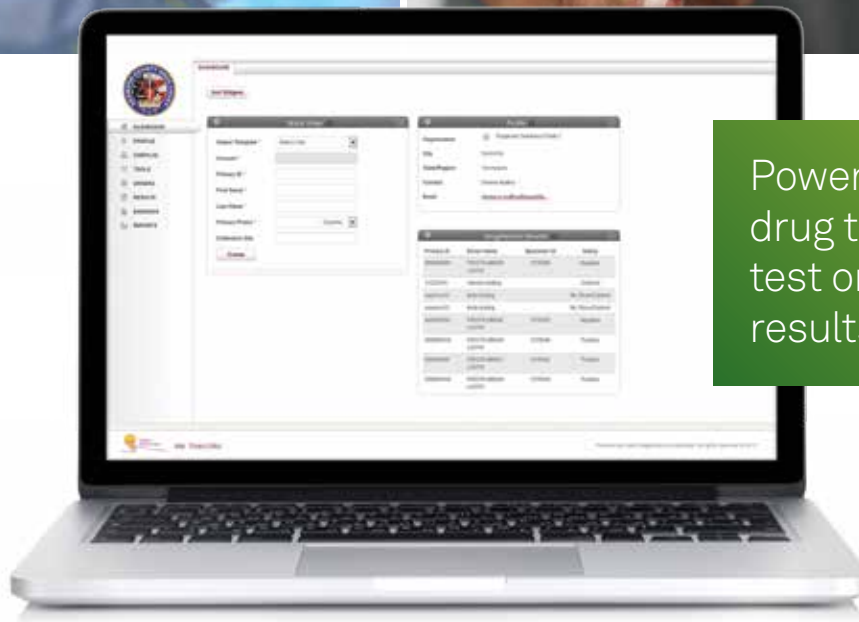
Oral-Eze® oral fluid testing

Oral fluid provides an observed, tamper-resistant collection that is less intrusive than urine testing. Gender-neutral observed collections are perfect for on-site random testing.

Hair testing

Hair testing provides up to a 90-day detection window for repetitive drug use patterns, making it an ideal way to help confirm drug-free program compliance. The likelihood of tampering or adulteration is also reduced as collections are observed.
