



PARENT & SPECTATOR CODE OF CONDUCT

As a parent, guardian, family member, or spectator participating in Hernando Soccer Club activities, I agree to the following:

1. I accept responsibility for ensuring that my child complies with the Hernando Soccer Club Player Code of Conduct and all applicable Club, league, and FYSA rules and policies.
2. I will treat players, coaches, referees, volunteers, board members, league officials, and spectators with respect and conduct myself in a sportsmanlike manner at all times.
3. I will not engage in harassment, bullying, discrimination, intimidation, threats, referee abuse, verbal abuse, physical misconduct, retaliation, or the use of foul, abusive, or inappropriate language toward any participant, volunteer, official, or spectator.
4. I understand that unsportsmanlike behavior, arguing with referees or officials, confronting coaches, volunteers, or board members in an inappropriate manner, or engaging in conduct that interferes with the safety, operation, or enjoyment of Club activities may result in disciplinary action.
5. I understand that alcohol, illegal drugs, and controlled substances not lawfully prescribed are prohibited at Club activities. Individuals who appear to be intoxicated or impaired may be required to leave Club property immediately.
6. I understand that smoking or vaping is permitted only in designated areas established by the Club or facility owner.
7. I understand that pets are not permitted at Club activities unless specifically authorized by the Club or required as a service animal under applicable law.
8. I accept responsibility for my conduct and the conduct of any family members or guests attending Club activities with me.
9. I understand that conduct occurring in person, electronically, through social media, text messaging, email, or other forms of communication that negatively impacts players, coaches, referees, volunteers, officials, or the Club may be subject to disciplinary review.
10. I agree to promptly report concerns regarding player safety, injuries, misconduct, or violations of Club policies to appropriate Club leadership.
11. I acknowledge that participation in Hernando Soccer Club programs is subject to the Club's bylaws, policies, procedures, disciplinary processes, and decisions of Club leadership and the Board of Directors.
12. I understand that violations of this Code of Conduct may result in disciplinary action, including verbal or written warnings, removal from Club property, suspension from attendance at Club activities, suspension of participation privileges, or removal from the program in accordance with Club policies and disciplinary procedures. INJURY, CONCUSSION, AND MEDICAL INFORMATION ACKNOWLEDGMENT:

I understand that participation in soccer involves the risk of injury, including concussions, head injuries, fractures, sprains, heat-related illnesses, and other medical conditions. I agree to notify Hernando Soccer Club as soon as reasonably possible of any injury requiring medical treatment, emergency care, hospitalization, concussion evaluation, or participation restrictions. I understand that players suspected of sustaining a concussion or head injury may be removed from participation and may not return until cleared in accordance with applicable medical guidance, Florida law, FYSA requirements, and Club policies. I certify that all medical information, emergency contacts, allergies, medications, and health conditions provided during registration are accurate and will be updated if changes occur during the seasonal year.

WEATHER, FIELD CONDITIONS, AND SCHEDULE ACKNOWLEDGMENT:

I understand that practices, games, tournaments, events, and other Club activities may be postponed, canceled, relocated, shortened, rescheduled, or otherwise modified due to weather, field conditions, facility availability, safety concerns, acts of nature, governmental actions, public health concerns, or circumstances beyond the Club's control. I understand that such modifications do not automatically entitle participants to a refund and that all scheduling decisions made by the Club are final.
