Updated Guidelines for Gravesite Decorations

Approved October 2017, Revised August 2023

Dear Association Members:

The Edmondson Cemetery Board of Directors has revised the guidelines for decorations on gravesites as follows:

Any item placed on a gravesite shall be a maximum height of 12". This includes (but is not limited to) vases, wreaths, garden statues, flags, toys, plaques, ornaments, solar lights, flowers, shrubs, or shepherd's hook. In addition to the headstone only **two** items per gravesite are allowed. Also, any ground cover on top of the dirt or grass which interferes with grass

cutting or weed eating is prohibited. The unapproved items will be removed.
