

TOWNE LAKE HOMEOWNER'S INC. Board Meeting, March 10th, 2025

The Towne Lake Village Homeowner's Association Monthly Board meeting was held on February 10th, 2025, at 6:30 pm in the HOA clubhouse.

Members Present: President, David Jacobs, Vice President Bobby Hunt, Ruben Juarez, DeAnn Yoder, Newt Hudson

Absent: Allison Benton, Greg Lewellen

Board President David Jacobs called the meeting to order

The minutes from February 10th, 2025, board meeting was reviewed. Bobby Hunt made the motion to accept the minutes. Ruben Juarez seconded the motion. All were in favor and the motion carried.

David Jacobs presented the Financial Reports, Motion to accept the reports were made by Bobby Hunt and seconded by Ruben Juarez. A motion was made by David Jacobs made to transfer \$4000.00 to Road Fund, and \$1000.00 to the Saving's Account from the General Account. Ruben Juarez seconded the motion. All were in favor and the motions carried.

Open Forum:

Robert Davis presented the board with a brochure from Beyond Your Ordinary, for playground equipment for Towne Lake Village. The playground equipment consists of Sliding Activities (2): Double Super Sonic Slide, Super Sonic Slide, Climbing Activities (2): Funnel Chunnel Climbing Link, Surge Climber. Sensory & Dramatic Play (1): Play Wheel, Wheelchair Half Ramp. Playground Mulch will be for safety. The cost of this project is \$16,654. Plus, tax. In the future park benches could be put in with the help of the community, with donations. The board would like to thank Robert Davis and the committee for all the work that has been involved. The community is seeing more and more families with children moving into the community, this will be such an asset for Towne Lake Village. A motion was made by Bobby Hunt to accept this bid, Ruben Juarez seconded the motion. All were in favor and the motion carried. Ruben Juarez, a retired contractor, which is on the board will be over seeing the installment of the Playground Equipment along with other volunteers

Old Business:

The TLV Board is still making ongoing efforts to stay in contact with the city about the issues of the area in green belt of flooding issues and all the debris that has settled back behind the pool. David Jacobs had a phone call with Kevin Chumbley of Public Works with the City. The board will continue making all the resources to get the city involved.

Kyle Stephens (Stephens Engineering) has been contacted by phone calls and emails about Lexington Court, for a survey for the construction of the street as of March 10th, 2025, there has not been any responses. David Jacobs will continue to make efforts to contact Mr. Stephens.

OpTex virtual loop for free exit.

4" OD bollard – galvanized & painted safety vellow.

Amendment to Declaration – Did not have enough response at the Annual Meeting.

The board realizes that this is going to take effort on their part to go door-to -door or make phone calls to inform Homeowners of the importance of this issue. All agreed to make as much effort as is needed.

With there being no additional business, Ruben Juarez made a motion to adjourn the meeting. Bobby Hunt seconded the motion. All were in favor.
