

**CITY OF FAIRFIELD**  
**Special City Council Meeting #FY 26-5**  
Thursday, January 8th, 2026, 7:00p.m.

Mayor Terry Lee called the City Council meeting to order at 7:00 p.m. City Clerk Sonja Chrysler took roll call. In attendance were Mayor Terry Lee, council members President John Pine, Josh Bovey, Ted Miller, and Tyler Ballard. Also, in attendance were Public Works Supervisor Jerry Scovil, and Planning and Zoning Administrator Ed Reagan. In the audience were Rodney Blount, Amy Martin, Troy Martin, Erika Whittaker, and Travis Kramer.

**APPROVAL OF AGENDA:** *Council President John Pine motioned to approve the agenda, second by Councilmember Ted Miller. Motion passed 4-0.*

**CONSENT AGENDA:** *Councilmember Josh Bovey motioned to approve the consent agenda as a whole, second by Council President John Pine. Motion passed 4-0.*

**NEW BUSINESS:**

- A. Best Community Renovation Projects 2025 – ACTION ITEM:** Mayor Lee announced that The Cliff Bar and Soldier Creek Brewery are receiving plaques for the work they have done to their establishments on Main Street for the Best Community Renovation Projects in 2025.
- B. Swearing in of newly elected City Council Officials Amy Martin & Rodney Blount – ACTION ITEM:** Mayor Lee swore in the newly elected Councilmembers Amy Martin and Rodney Blount for 4-year terms. John Pine and Josh Bovey were presented with plaques and thanked for their dedicated years of service as Councilmembers.
- C. Resolution 2026-01 Council Rules of Procedure – ACTION ITEM:**  
Councilmember Tyler Ballard motioned for the 1<sup>st</sup> reading of Resolution 2026-01 by title only, second by Councilmember Ted Miller. Motion passes 4-0 Mayor Lee reads Resolution 2026-01 by title only. Councilmember Tyler Ballard motions to waive the second and third reading of Resolution 2026-01, second by councilmember Ted Miller. Motion passes 4-0 Councilmember Tyler Ballard motions to adopt Resolution 2026-01 by title only, second by councilmember Amy Martin. Motion passes by rollcall vote, Tyler Ballard - “Aye”, Ted Miller – “Aye”, Amy Martin – “Aye”, Rodney Blount – “Aye”. Mayor Lee reads Resolution 2026-01 by title only and declares it adopted.

- G. Sun Creek Discussion – Final Platt Discussion – ACTION ITEM:** No discussion.


## **REPORTS**
