Henry (II),2nd St.Clair/42nd dynastic 'Prince'-Jarl(*Earl*) of Orkney,5th/11th Feudal Baron of Roslin/Rosslyn,,*de facto/jure* 1st Lord Sinclair(1410) (b.c.1375-d.c.1418/20),m.(1407) Egidia 'The Fair Maid of Nithsdale',dau. of Sir William Douglas of Nithsdale(b.c.1370-k.1391) [*illeg.son of Archibald 'The Grim',3rd Earl of Douglas*] by his wife (m.1387)Egidia/Gelis,Stewart,Baroness of Herbertshire and Nithsdale,ygst. dau. of King Robert II of the Scots by his 2nd wife(m.1355) Euphemia(d.1386),dau. of Hugh/Aodh,4th Earl of Ross by his 2nd wife Margaret,dau. of Sir John de Graham of Abercorn;Henry and Egidia had with a dau.[*Beatrix,wife of James 'the Gross' of Balvenie,7th Earl of Douglas and 1st Earl of Avondale*],a son:

William,3rd St.Clair/43rd and final dynastic 'Prince'-Jarl(*Earl*) of Orkney[resigned 1470/1],1st/2nd Lord Sinclair(c.1449),1st Earl of Caithness(created/granted 1455-resigned 1476), 6th/12th Feudal Baron of Roslin/Rosslyn(resigned 1476) and Ravenscraig/Dysart(granted 1470-resigned 1476),Lord High Admiral of Scotland, Lord Chancellor of Scotland(1454-6).Founder of Rosslyn Chapel(1446). (b.c.1410-d.c.1480/4) Earl William,m.(1) Elizabeth(d.c.1451),widow of John Stewart,2nd Earl of Buchan(b.c.1481-k.17th Aug.1424,Verneuil) and Sir Thomas Stewart,Master of Mar(m.c.May 1427-d.c.Aug.1432),and eldest dau. of Archibald 'Tyneman',4th Earl of Douglas and 13th Lord of Douglas,,French Duke of Touraine and Lieutenant-General of France(April 1424) (b.c.1369-k.17th Aug.1424,Verneuil) by his wife (m.1390) Margaret Stewart,Lady of Galloway (d.c.1450/6),dau. of King Robert III of the Scots and his wife Annabella Drummond;Earl William,by this 1st marr.,left with 1-2 daus.,an only son:

William Sinclair 'The Waster/Spendthrift'.*disinherited* Master of Orkney and Caithness,*de facto/jure* 2nd/3rd Lord Sinclair,hereditary Feudal Baron of Newburgh and Ravenscraig(after 1481) (b.c.1437- d.c.1487),m.(29th April 1458/*papal disp.: as both were matrilineal desc'ts of King Robert II of the Scots*) Christian/Christina (d.aft.20th Feb.1491/2),dau. of George Leslie,1st Earl of Rothes,had with 1 dau.,3 sons,of which:

Sir Henry,recog./confirm. as Clan Chief as (3rd/4th) Lord Sinclair(Jan.1488/9) ,Feudal Baron of Ravenscraig(and Cousland,4th Dec.1488),Dysart(9th Jan.1493/4) and Newburgh(1503,3rd Mar.1508/9), Justiciar/Foud/Bailie of Orkney and (Sh/Z)etland,as well as Captain/Constable of Kirkwall Castle (28th May 1489,1st May 1501),royal Master of Artillery(18th March 1510/1),royal Captain of the ship *Great Michael* (1512) (k.9th Sept.1513,Flodden Field);but by his wife Margaret,sister of Patrick Hepburn,1st Earl of Bothwell and 2nd Lord Hailes,he left issue,whose legit.male-line became either extinct or dormant between 1674/6-1710[*incl.the Danish line of Sincklarsholm,1590/1-1681*] {*see Gen.Chart No. 1*}

B 2. Sir William Sinclair,1st of Warsetter,Sanday in Cross and Burness Parish,Orkney.....,Justice of Orkney (c.1487-1522,d.c.1527),**SEE NEXT**

B 3. Magnus Sinclair,witness to an assig. of the redemption of the 2 Haddochis(29th Sept.1487),but presumed identical to the putative Tacksman of the Bull of Cairston(d.c.Feb.1528) in Stromness Parish,Orkney,who m.Margaret(c.20th May 1528),dau.-coheiress of Alexander Sinclair and his wife Margaret Wilson,leaving , at least a son,John ,1st of Tohop(e)(*Tolhuip*)/T(r)oll(a/o)p aka To(a/o)b in St.Andrews Parish,Orkney(c.17th Mar.1523-d.c.Aug.1568),whose now extinct or dormant male-line of Saba(*Seba*),produced the 2 distinctive and separate Swedish branches of the Barons Sinclair of Finnekumla(1714-ext.1803) and Counts Sinclair of Lambahof(1771-ext.1919),as well as possibly the brief Alsatian ennobled line of Niederbronn- Oderbronn (c.1695-ext.1733) {*see Gen.Chart No.4*}

[NB Sir William was cited by Roland William Saint-Clair(RWS) as being father to the aforesaid John of Tohop/ Trollap and Toab/Tobe,which was disputed by Joseph Storer Clouston(JSC),who has now again,been vindicated..]

Earl William,m.(2:c.1456) Marjory(b.c.1436-c.1456),dau. of Sir Alexander Sutherland,Laird-Baron of Dunbeath (b.1395-d.c.Nov.1455/6,will dated 15th Nov.1456,bur.Roslin Chapel) ,who m.(c.24th Oct.1429) Mariota MacDonald (b.c.1404/15-d.20th July 1448), dau. of Donald/Domhnall of Islay,8th Lord of the Isles (b.c.1364-d.c.1423) – *both Sir Alexander and Mariota were cognatic 2nd cousins,as both were matrilineal great-grandchildren of King Robert II of the Scots by his 1st wife Elizabeth Mure(of Rowallan)*- by his wife Mariota,Countess of Ross(c.1382-d.1440),dau. of Sir Walter Leslie(c.1356-d.27th Feb.1382) by his wife Euphemia I,(7th) Countess of Ross(c.1370-d.c.1394/8).Earl William, by this 2nd marr.,had a large brood of 6 sons and 7 daus.,of which :

A 2. Sir Oliver Sinclair,7th/13th Feudal Baron of Roslin/Rosslyn(disponed from father,9th-12th Sept.1476),whose legit. male-line became either extinct or dormant 1778. {*see Gen.Chart No.5*}

William Sinclair,2nd Earl of Caithness(from 7th Dec.1476,b.c.1459/60-k.9th Sept.1513,Flodden Field),who m.Mary,dau. of Sir Gilbert/William Keith of Inverugie;and left legit.male-line issue,who are still extant Earls of Caithness.and since 1778(unofficially) and 1969(officially),are the recog./confirmed paramount Chiefs of the Clan Sinclair.

- IV. Sir William Sinclair, 1st of Warsetter, Sanday in Cross and Burness Parish, Orkney....., Justice of Orkney (c.1487/97-1522, d.c.1527), m. Ellen/Helen(e)/Eleanor Gordon, putative dau. of either George Gordon, 2nd Earl of Huntly and 3rd/final wife Elizabeth Hay OR George's 2nd son Adam Gordon, 10th Earl of Sutherland ; by whom, he had:
- A 1. Magnus, 2nd of Warsetter (d. bef. 8th Aug. 1546), fought at Summerdale and was the 2nd name cited after his half-bro. Edward in the well-known Respite (19th Sept. 1539); he, m. Janet Keith, and had:
- B 1. William of Warsetter (c. 8th Aug. 1546-d. bef. 6th Feb. 1586/7), who had, with possibly other issue:
- C 1. Agnes, eventual heretrix of Warsetter (c. 6th Feb. 1586/7),
m. Henry Sinclair of Towquoy/Tuquoy and Warsetter (c. 9th Nov. 1597)
[NB(1) RWS(p.139) has by mistake, conflated Agnes' husband, twice, as 3rd Laird (23rd Dec. 1597: anti-Balfour complaint) and 5th Laird (3rd Oct. 1627), while totally 'airbrushing' Agnes, her father William and her great-aunt Agatha all out! (2) RWS(pp.146-7) notes him as one of 1592 anti-Stewart petitioners, but then presumed him to be identical to 'Henry of Clumlie' (c.1612), who is rec. as dec. by July 1621 as his dau. Katherine, wife of Robert Coltart, merc. in Kirkwall, followed by his wife Margaret Craigie (June 1622), are trying to rep. his estate!?!] ; and had, with possibly other issue:

Sir William, by an earlier 'liaison' with local Orcadian gentlewoman Cristane Cara/Cromarty, had:
- A 4. Sir James of Brecks, Eday, Sanday and Stronsay, rebel Gov. of Kirkwall (1528-9) and Justice of Orkney (1535-6); probable '*James Sincler, capitane for the tym in Dingvell*', cited as a main beneficiary/legatee of Sir David Sinclair of Swinburgh/Sumburgh, former Foud of Shetland's will (dated 6th July 1506), and received a Privy Seal Reg. rec. precept of legitimation (17th June 1535) alongside his bro. *David (of Brough/Burgh)* and their respective illeg. sons. In the interfamilial turmoil, he successfully led the islander opposition which defeated their mainland kinsmen led by William, 4th/5th Lord Sinclair (captured) and John, 3rd Earl of Caithness (killed) at the battle of Summerdale (*Bigswell*), field of Stenness, Garmiston neighbourhood, Par. of Stenness and Firth (18th May 1529), but later on, reportedly committed suicide (c.1536), leaving issue, by his wife, Barbara, later Lady of Burray and eldest dau. of Andrew Stewart, 1st/2nd Lord Av(a/o)ndale and 2nd feudal Baron of Morphee [*Barbara, m. (2:1541) Ruairidh Macleod, 10th Chief of the Lewes*]:
- B 1. Margaret, who m. (1: div. bef. Jan. 1564) [*as his 1st wife*] James Tulloch, portioner of Lambholm (c. 8th Nov. 1560-90); and probably had:

(2: 1563/5) Mr. Magnus Halcro of Br(o)ugh (*Burgh*) in Rousay, Chantor/Precentor of the Cathedral Kirk of Orkney (*ie St. Magnus Cathedral, Kirkwall*), nominal/titular chaplain of St. Giles (*St. Egidii*) benefice in the Par. of Tingwall, Shetland and later Parson of Orphir (from 1555/60-75, d.c. July 1584), leaving issue:

late medieval copyist's mistake for Edward, although it is also possible he might be the 'unrecorded' father of the 3 slain nephews (*David, Nichol, John*) killed in pre-Summerdale turmoil of 1528-9 and cited by the defeated/ousted kinsman and clan chief William, 4th/5th Lord Sinclair in his later official complaint to the royal authorities.

(1) Rosalind, Mitchison,FRSE was the academic debutant author of the widely acclaimed 'Agricultural Sir John' (1962);a contextualised biography of Sir John Sinclair,1st Baronet of Ulbster,with a foreword by Sir John's lineal 3 x gt.-grandson the late Sir Robin Macdonald Sinclair,2nd Viscount Thurso and 5th Baronet of Ulbster, after the latter's father the Liberal Party wartime leader Sir Archibald,4th Baronet and 1st Viscount had commissioned a new biography to celebrate Sir John's birth-bicentenary(1954) and been recommended Rosalind by her mentor the interwar/postwar historian Sir Lewis Namier(b.27th June 1888-d.19th Aug.1960)

NB It is not clear whether either the Ulbster family or Rosalind really deduct the Warsetter family kinship through her husband John Murdoch Mitchison's matrilineal bloodline;although a weirder coincidence for myself,is that Rosalind's father-in-law Gilbert Richard 'Dick',Baron Mitchison of Carradale(LP-5th Oct. 1964,b.23rd Mar.1894-d.14th Feb.1970) was the postwar MP (1945-64) for my main home-town of Kettering in Northamptonshire!

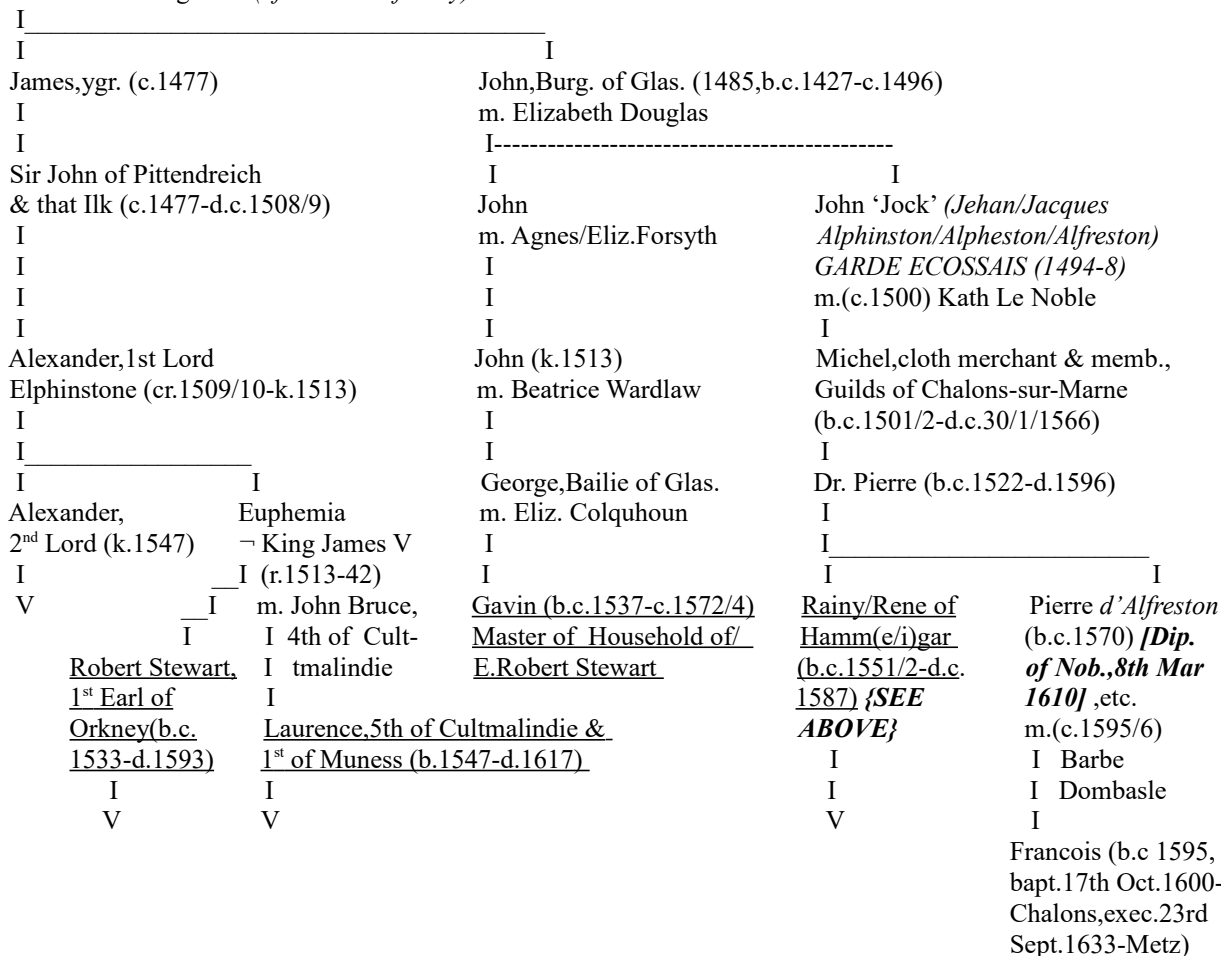

- (3) As noted,Receiver-General Malcolm Laing's Jamaican business dealings with John Ja(c/q)ues,1st Mayor of Kingston came under the auspices of '*Jacques,Laing and Ewing*',a commercial venture eventually inherited by Malcolm's next/nearest (*legitimate*) heir-at-law,his nephew James of St.Ann Parish and later of the Taplow estate in Buckinghamshire,who named his eldest son 'Malcolm Jacques'

At the time of his death(1781),Malcolm,was one of the richest men in Jamaica,with his overall estate being estimated to be worth £88599.61 Jamaican currency,of which £2390 were the value of enslaved people,another £81451.83 were currency debts and £1058.5 currency plate.Trevor Burnard's book,'*Planters,merchants and slaves*'(2015),p.160 shows Malcolm's estate valued as £63,285,the bulk of it debts receivable rather than the 93 enslaved people he held! Taken into account,at today's valuation, £63,285(c1780) = £12,103,251.82(c.2022) and £88,599.61(c.1780) =£16,944,669.21(c.2022)!

NB John Ja(c/q)ues's putative great-grandson was George Samuel Ja(c)ques,whose eldest child Amy Euphemia (b.31st Dec.1895-d.25th July 1973),pioneering female black journalist and publisher,as well as being the 2nd wife(m.27th July 1922) of prominent black civil rights activist Marcus Mosiah Garvey,Sr. (b.1th Aug.1887-d.10th June 1940),bearing him,2 sons: Marcus Mosiah Garvey III (b.17th Sept.1930-d.8th Dec.2020) and Julius Winston Garvey(b.1933).

Madeleine, m.(1st May 1650) Charles-Jean Colbert du Terron, Marquis of Bourbonne & Torcenay (b.19th Mar.1628-d.9th April 1684), founder of the Rochefort naval base (Dec.1665) and paternal 1st cousin of Jean-Baptiste Colbert, chief minister of King Louis XIV]
- (c) Dr. Pierre (b.c.1522-d.1596), was recorded as a medical student (1553) at Paris University, and by his wife (m. c.1550) Madeleine Clement, (*de l'Espine*) by whom he had Rainy/Rene {*see above*}, Pierre (b.c.1570, c.1607-24) and Collette (b.c.1569).....
- (d) Sieur Pierre d'Alfreton, squire [ecuyer] (b.c.1570-c.1607-24), became a prominent and influential civic & regional lawyer in the family's (adopted) home-town of Chalons-sur-Marne [*now Chalons-en-Champagne*] : Lieutenant-criminal in Vitry-le-Francois (1609), Bailiff & Pres. of the Council of Chalons-sur-Marne (1610/6), recorded royal notary (1611) and received a formal Diploma of Nobility [*Letters Patent*, 8th Mar.1610], later becoming municipal Gov. & Bailiff (*Lieutenant*) of (the Bishopric of) Chalons-sur-Marne (1617/22)
- NB (1) Unsure, whether some of these positions were inherited by his son, the unfortunate Francois.
- (2) It is unclear what Pierre's actual landed properties were, as from the records of his son's trial, he referred to as 'Lord of Joyeuse (*Joyeulx*) & Auvergeres' OR 'Lord of Montois & Francheville' (10th July 1597)
- (3) His 1610 Diploma of Nobility (*initially regd. in Edinburgh*) narrated his great-grandfather 'Jock' as a brother of William Elphinstone, Bishop of Aberdeen (1483-1514), when genealogically they were 1st cousins, once removed
- (e) Francois d'Alfreton, squire [ecuyer], Lord of Joyeuse, was a young officer who had served in the guards of the late Jean-Louis de Marillac, Comte de Beaumont-le-Roger (1572- exec. 10th May 1632), Marshal of France, who had been a strong supporter of Marie de Medici, Queen Consort/ Regent/Mother of France and Navarre, along with her younger son Prince Gaston, Duke of Orleans against the court & political intrigues pushed by her elder son King Louis XIII (r.1610-43) and his chief minister, Cardinal Richelieu 'The Red Eminence' [*the latter, initially beginning his political rise, as a protege of Marie de Medici, before switching his allegiance(s)!]*
- After Marillac's execution on trumped-up charges, Francois became intertwined in a supposed plot in early Sept.1633 spearheaded by arch/anti-Richelieu plotter Father Jacques d'Apchon, Lord of Chantelou (b/p)e 'Father Chantelou (b/p)e' (c.1618-d.Feb.1641), with the putative backing of Marie de Medici to assassinate Cardinal Richelieu in Metz.

The plot was quickly uncovered, with King Louis XIII ordering the local parliament of Metz to conduct Francois' trial on 15th Sept.. Francois, was duly interrogated on 17th Sept. and 8 days after his arrest, on 22nd Sept., the Parliament of Metz declared him guilty of the crimes of 'lese-majeste in the 2nd degree' with conspiracy against the Cardinal.

The judgment was signed on the registers by Antoine de Bretagne (1st Pres.), Nicolas Rigault and Guillaume Fremyn; with Francois being duly executed the next day, by being 'broken and burnt alive' in Metz's Square of Champ-a-Seille (formerly the site of the military Coislin barracks (1726-1930) and now presently the site of

'Place Coislin' and the adjoining fountain) !

[NB (1) the main evidence, used to convict Francois d'Alpheston of his part in the supposed plot was, apart from hearsay, his use of 'a large dappled gray gelding' known as 'The Great Gelding OR Polacre', regularly seen in the private stables of Marie de Medici; for which the horse, was sent back to Paris on the Cardinal's express orders in Jan. 1634, before being returned by King Louis XIII to his mother; at the suggestion of the Cardinal himself, underlining the indirect responsibility of Marie de Medici in the affair !

(2) The whole affair came at a turbulent period in French politics & history with the internal civil war against the Protestant Huguenots and the besieged fall of La Rochelle (10th Sept. 1627-28th Oct. 1628), leading to the Peace of Alais/Edict of Grace (28th June 1629), all containing the Anglo-French war section of the continent-wide Thirty Years' War (23rd May 1618-24th Oct. 1648) - alongside Richelieu's myriad of duplicitous foreign treaties : Compiègne (10th June 1624), Mon(c/z)on (5th Mar. 1626), Su(s/z)a (11th Mar./14th Apr. 1629), Barwalde (23rd Jan. 1631), Fontainebleau (30th May 1631), Cherasco (June 1631), Saint-Germain-en-Laye (29th Mar. 1632), Compiègne (30th Apr. 1635), Wismar (20th Mar. 1636), Hamburg (5th Mar. 1638) - plus Louis XIII & Richelieu's joint policy of centralised government (leading to the eventual 'absolute monarchy' of Louis XIV), meant Richelieu created many enemies, both high & low, leading to many conspiracies, incl. Henri, 4th Duke of Montmorency's rising (Sept.-Oct. 1632) and the politically motivated persecution of Rev. Urbain Grandier in the notorious 'Loudun possession affair' (Nov. 1633-Aug. 1634)

- (5) There is good reason to believe Andrew Smith of Ackergill, was presumably identical, if not near kin, to Andrew Smyth, 1st of Rothiesholm and Rapness [**Ork.**], bro. of Patrick Smith/Smyth(e), 3rd of Braco [**Perths.**] & 1st of Maill/Meall [**Ork.**], both wards of George Graham/Graeme of Gorthie & Myreside (b. 1565-d. 19th Dec. 1643), later Bishop of Dunblane and then Orkney {lineal cadet of Inchbraikie}

Patrick Smyth(e) (d. 25th Apr. 1655), later married (contract, 24th June 1618.) as his 1st wife, his guardian's .dau. Catherine (d. 13th Oct. 1637), and by her, he became the progenitor of Smyth(e) of Methven Castle; whilst his bro. Andrew's son George Smyth(e) of Hurlesso, 2nd of Rapness (b. 1633-d. 1666) m. (..... 1653) Annas (b. 1634-d. 1699), dau. of Col. Patrick 'Black Pate' Graeme, 5th of Inchbraikie [paternal gt.-nephew of Bp. George]

Andrew Smith of Ackergill's attributed 4 daus., all made suitable Orcadian civic & mercantile marriages:

- Elizabeth, m. (1: 1615) Robert Elphinstone of Hammegar & Brugh; (2: c. 1629) James Cock of Bea
- Barbara; m. James Baikie, 1st of Tankerness (b. c. 1600-d. 16th Jan. 1675), Steward-Depute of Orkney..... & Provost of Kirkwall.....
- Margaret; m. Thomas Buchanan, 1st of Sound, (c. 7th April 1643-d. bef. 12th Feb. 1656), Sheriff-Depute of Orkney (c. 10th Aug. 1647) & Provost of Kirkwall (1638-47)
- Jean; m. (contract, 9th April 1620) Robert Bellenden of Midhouse [ygr. son of Sir Patrick Bellenden of Stenness & Evie, Sheriff of Orkney]; in a charter (dated 7th April 1620), where Jean is specifically noted as 'niece' of Dame Margaret Hartsyde (dau. of Malcolm H(e)arts(i)y de in/of Kirkwall, Orkney), wife of Sir John Buchanan of Scotsraig, Sheriff-Depute of Shetland & uncle of Thomas Buchanan of Sound

NB A later Halcro family charter (dated 10th Aug. 1647), incl. Robert Bellenden's ygr. dau. Anna and Thomas Buchanan seems silent to ambiguous, about the family kinship, which implied that Jean might not have been of the same marriage set as the other daus. of Andrew Smyth.

[NB Both/either wives of the 2 Adam Smith/Smyth(e) seems to be unrecorded; although it is more probable that the Laird of Rothiesholm and Rapness, would have followed his bro. and opted for a dau. of Bp. Graham's kin of Inchbraikie, etc.; whilst there is good reason to believe Andrew of Ackergill's wife & mother of some of his daus., was a member of the comital Stewart line of Orkney : probably Robert Stewart, 1st Earl of Orkney's legitimate dau. Barbara, cited as marrying Hugh (Hew) Halcro of Halcro, but invariably confused with her 1st cousin [dau. of Adam Stewart, Prior of the Charterhouse, Perth : natural son of King James V by Elizabeth/Helen Stewart, dau. of John Stewart, 3rd Earl of Lennox], wife of Henry Halcro of Halcro OR a more remote cousin [dau. of Andrew Stewart, Lord Av(a/o)ndale & sister of Henry Stewart, 1st Lord Methven, 3rd/final husband of Margaret Tudor, mother of King James V], wife of Sir James Sinclair of Brecks, Eday, Sanday & Stronsay {see above}] from at least a century & generation (1-2) earlier !

- (5) That there is good reason to believe that Malcolm Scollay of Hunto(n) and Sanger in Stronsay, Orkney (b. c. 1646/8-d. aft. 1717) was the result of a probable 'cousin-marriage' between Harie Scollay in/of Strynie, Stronsay and an unrecorded granddau. of Harie's (putative) paternal great-uncle Duncan Scollay of Hermansgarth, Sanday [invariably through either of Duncan's 2 children (by his wife Is(a/o)bel, dau. of Malcolm Sinclair, 1st of Quendale), namely : Edward of Strynie OR Margaret, wife (m. 1631) of Robert Scollay in/of Tofts, Sanday]
- NB (a) Rothiesholm [Stronsay] and Strynie (then Strenzie) [Stronsay] split into a N. section known as Whitehall and a S. section called Hunton, all eventually came under the collective ownership of Malcolm Laing of Strynie (1763-1818) and then his brother Samuel Laing of Pa(b/p)dale (1780-1868)

- (b) The Laing family's rise had begun under James (1669-1753) *[see above]*, based at Easterquoy, Calf Sound, Eday, with a family farm at How in Shapinshay, alongside other estates at Shaltaquoy and Skenstoft, whilst gaining an Eday estate called Greentoft. James' son Robert (1722-1803) picked up in 1771, the extra Eday estates of Carrick and Stove, plus Strynie/Strenzie *[all 3, formerly part of the old Fea of Clestrain estates]*, followed in 1783 by the purchase of the lands of Pa(/p)dale, based E. of Kirkwall, then part of Eday, but now part of the Parish of St. Ola.
- (c) The discrepancy from Samuel Laing's Autobiography where he 'mistakes' his paternal grandmother Rebecca as a daughter of Malcolm Scollay of Odness, when his actual properties were 'Hunton and Sanger', as proved by the eminent Orcadian antiquary Dr. Hugh Marwick (1881-1965) in his academic paper 'Some Notes on an Old Orkney Family-The Scollays' published in 'Orkney Herald' (4th March 1952) and 'Orkney Record and Antiquarian Society' (Orkney Miscellany, Vol.1-1953)
