Select Board Minutes for
Monday, May 30, 2023

Present: S. Huff, R. Basford, B. Chase and four others

Meeting called to order 7:00 PM.

Motion made by (RB), seconded by (BC) to accept the May 15, 2023, Select board minutes; (SH) abstained due to May 15, 2023, absence; vote carried.

Motion made by (SH) and seconded by (BC) to pay Warrant # 22 Payroll; vote was unanimous.

Motion made by (SH) and seconded by (RB) to pay Warrant # 23; vote was unanimous.

A couple of concerned citizens discussed with the Select board a recent Facebook post, by a resident, saying that the Bicentennial funds were going to be used to buy Veteran banners to hang on the CMP poles. It was agreed that the Bicentennial funds could not be reallocated to buy Veteran banners.

Motion made by (SH) and seconded by (BC) to recess the Select board meeting and open the Special Town Meeting @ 7:30 PM; vote was unanimous.

Special Town Meeting to see what sum of money the inhabitants of the Town will vote to raise & appropriate for Snow Removal, Sanding & Salting of the Town roads for the ensuing year.

Motion made by (SH) and seconded by (RB) to reopen the Select board meeting; vote was unanimous.

Motion made by (SH) and seconded by (RB) to accept Harcros Chemical price for road salt @ \$78.60 a ton; vote was unanimous.

Motion made by (RB) and seconded by (SH) to accept Moonshine Gardens quote for mowing/bushhogging down behind the Veterans Memorial, at the Transfer station and at the Sand & Salt Shed; vote was unanimous.



Motion made by (SH) and seconded by (RB) to close the Town office on Friday, June 9, 2023, if need be, for the parking lot paving project; vote was unanimous.
