Monday, March 17, 2025

Meeting called to order 7:00 PM.

Motion made by (BC) seconded by (SH) to accept the March 3, 2025, selectboard minutes; vote was unanimous.

Motion made by (SH) seconded by (BC) to pay Warrant # 11 Payroll; vote was unanimous.

Motion made by (BC) seconded by (SH) to pay Warrant # 12; vote was unanimous.

At a resident's request, Sherri Thornton, our health officer, discussed Food sovereignty and the steps needed to make our town a food sovren town with the select board. After much discussion, no action was taken.

The selectboard reviewed the letter received from the Waldo County Clerk saying the Waldo County tax amount has been revised from \$266,140.44 down to \$250,329.05.

Motion made by (BC) seconded by (SH) to send a letter to Carl Creasey, CLC Lawn Care, stating the Town of Burnham has decided to opt out of the 2-year option on the Town & Cemetery Mowing Contract; vote was unanimous.

Motion made by (SH) seconded by (BC) to appoint Megan Anderson as Animal Control Officer; vote was unanimous.

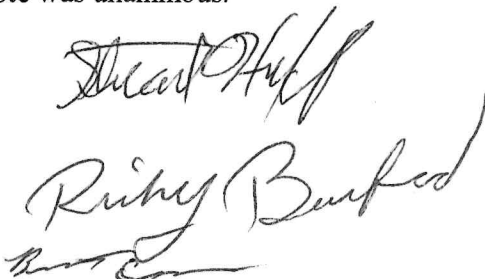
Motion made by (SH) seconded by (BC) to appoint Richard Castonguay & Brian Fletcher to the Appeals Board; vote was unanimous.

Motion made by (SH) seconded by (BC) to appoint Stacy Patterson as Clerk, Tax Collector, Excise Tax Collector, Registrar of Voters & Deputy Treasurer; vote was unanimous.

Motion made by (SH) seconded by (BC) to appoint Randy Hall as Code Enforcement Officer; vote was unanimous.
