Please verify this issue, we are providing 100% correct information on our village problem. We are **sitting around 120 homes entire board area**. Every night lots of people come here to play Andhar Bahar Gambling. **The whole night drunk players fight together and use bad language. We are always harassed sir; it's a very bad message to our children. Even after the evening, our children are scared to walk in our area.**

**IPS & IAS** officers always **deserve respect** we hope to immediately stop this corruption. We are still surprised that the Nabadwip PS In-Charge Officer: Shri Jaleswar Tewari did not stop the Illegal Board when lots of problems faced every village people. **Gambling Board owner Mr. Malay Sarkar says that he had given 10 lakh rupees to the Vice Chairman of the**

**Nabadwip Municipality Mr. Biman Krishna Saha**, also to give her Oral Permission & every month gave 5 lakh rupees to the Nabadwip Police, so nobody stopped him from running this **gambling board**. That's the reason, we are scared to complain against him at your local police station.
