**The first gambling board run**, by the Jirat bus stand, is located inside the **Sabuj Sangha Club**. Ten owners are running the illegal gambling board in the crowded Jirat Bus Stand area inside the **Sabuj Sangha Club**, **paying the club three thousand per day**. Notable among the owners of the illegal gambling board are **Mr. Swapan Mitra** (+91 8609956888) / **Mr. Tarun Biswas / Mr. Pintu Mitra** (+91 9933782756) / **Mr. Lala / Mr. Sanjit / Mr. Buro**, and many more. **Balagarh Police Station SI Somdev Patra took 3 lakh rupees in bribes** for a one-time verbal permission. **Balagarh Police Station SI Somdev Patra** gave verbal approval in exchange for a **weekly bribe** of 50,000 INR.

**Second gambling board run**, by the Jirat station bazar, is located inside the **YCA club**. Three owners are running the illegal gambling board in the crowded Jirat station bazar area inside the **YCA club**, **paying the club three thousand per day**. Notable among the owners of the illegal gambling board are **Mr. Gobindo Roy** (+91 7811031938) / **Mr. Sanjay Saha** (+91 8250166685) / **Mr. Babu Biswas** (+91 9735659472) / **Mr. Raju Halder /** and many more. **Balagarh Police Station SI Somdev Patra** took 2 lakh rupees in bribes for a one-time verbal permission. **Balagarh Police Station SI Somdev Patra** gave verbal approval in exchange for a **weekly bribe** of 30,000 INR.

**Third gambling board run**, by Jirat Paddapukur Ariya is located inside the **TNS club**, by **Mr. Chottu Das** (+91 9734578583) / **Mr. Sukhen Majumder** +91 (8617608772) many more. They are also paying **three thousand every day** to the Jirat Padmapukur **TNS Club** to run a gambling board inside the club. **Balagarh Police Station SI Somdev Patra** took 2 lakh rupees in **bribes** for a one-time verbal permission. **Balagarh Police Station SI Somdev Patra** gave verbal approval in exchange for a **weekly Bribe** of 30,000 INR.

**The fourth gambling board run**, by Khamargachi railway station area, Mr. **Surajit Malo** (+91 70039 01568). **Balagarh Police Station SI Somdev Patra** took 3 lakh rupees in **bribes** for a one-time verbal permission. **Balagarh Police Station SI Somdev Patra** gave verbal approval in exchange for a **weekly bribe** of 50,000 INR.

**The fifth gambling board runs**, The Guptipara Rathtala Bagan Gambling Board, run by Mr. Lalu & Mr. Godai (+91 6297498026), clearly states that he has been giving a **monthly bribe of 5 lakh** to **Balagarh PS SI Somdev Patra** to operate this **gambling board**.

**The sixth gambling board runs**, A little further from the Korla intersection, next to the closed petrol pump, opposite the Dada Bhai Line Hotel, down the road next to the tire repairing shop, there is a gambling board inside a new building (1-floor building). Gambling Board run by Mr. **Joydeb Biswas** (+91 7865998317) / **Rafik Shaikh** (+91 8207298426) and **Sanjit Das** +91 9093979976 (**The local boy of the illegal appointment Dak Babu, Mr. Sanjit Das, appointed by Balagarh Police Station, Jirat, used to work as a civic volunteer and is now the Dak Babu Mr. Sanjit Das, of Balagarh Police Station.**) **Balagarh Police Station, illegal recruitment: Dak Babu, Mr. Sanjit Das, since there is a 50% partnership here, Balagarh Police Station, SI Somdev Patra, they only take a monthly bribe of 1.5 lakh rupees. Balagarh Police Station, Illegal Appointment: Dak Babu, Shri Sanjit Das, behalf of Balagarh Police Station, SI Somdev Patra collects weekly and monthly bribes from all Illegal Gambling Boards.**

Local people have raised objections many times to **Balagarh PS SI Somdev Patra, but to no avail**. Furthermore, they were **attacked by the gambling owners' pet thugs**. If you look into the matter, you will understand **how Balagarh PS SI Somdev Patra has been tarnishing the name of the current government day after day for his own personal gain**. **How Balagarh PS SI Somdev Patra has defamed the name of senior police officers just for his own profit. Superintendent of Police Hooghly Rural Shri Kamanasish Sen, IPS, his image is getting bad among the public because All Gambaling Board Owners & Balagarh PS illegal appointment Dak Babu, Mr. Sanjit Das (+91 9093979976) surprised everyone by saying that we give money to our SP and leaders so no one can do anything to us. They have also defamed Superintendent of Police Hooghly Rural Shri Kamanasish Sen, IPS. Sir. People know that an IPS officer would never do such a heinous act. IPS & IAS officers always deserve respect we hope to immediately stop this corruption. Honorable Madam CM and all respected officers think about it, it is not a small matter, and they should be punished so that such things cannot be said in the name of an IPS officer.**

**Great Investigation going on** Every night at 11 pm, the Balagarh police call the gambling board owner and say, "We are coming. Turn off the lights. We will make a video for 2 minutes." It's **ridiculous**, when an **IPS officer is corrupt, he tries to protect illegal business like this. The public is very aware that such an investigation is never possible without the permission of the Hooghly SP.**

We never want to tarnish the reputation of senior police officers, but after they were informed of everything via What's App on 13/07/25, they are challenging us without looking into the matter. They are so busy taking bribes that they have forgotten that there are laws and regulations in the country. Hon'ble Chief Minister Smt. Mamata Banerjee has repeatedly held press conferences and clearly informed the police administration that she will not tolerate bribery at any cost, but unfortunately, some corrupt police officers are unable to refrain from accepting bribes. But we are now losing confidence in the current government's actions. If the current government is so concerned about police bribery, then why is it not taking action even after submitting a written complaint? It is surprising how clubs are turning into gambling dens. One day, we will see that even primary schools are hosting gambling dens at night. Just think about where the current government's image is going in the eyes of the public. We know that the country's legal system is for everyone, so we will highlight the issue more forcefully in front of the entire judicial system and the media of the country. The activities of the corrupt police will be exposed in front of all important departments every hour until the gambling boards are closed. All important departments will receive copies of the complaint via courier if the senior police officers in charge do not close the gambling boards by today. For the past 2 years, many outside criminals have been coming to our area to gamble, resulting in incidents of theft and robbery becoming a daily occurrence. All the young men and women in the village are becoming addicted to this gambling addiction day by day and they are becoming completely destitute. Many families are being destroyed by this gambling addiction. The people of the village are afraid to go out after dark because there are many criminal dens in our village. We kept our identities secret because Balagarh PS SI Somdev Patra himself is taking huge sums of money from the gambling boards, the protector has now become the eater. We hope the present government will investigate the matter promptly and take the necessary legal action (Find the attachment). We just want to live peacefully.**
