Currently, we have informed the matter to the IC of **Nadanghat Police Station**, Mr. **Biswabandhu Chattaraj** (+91 9147888565) and the **Superintendent of Police, Purba Bardhaman**, Shri, **Sayak Das** (IPS), requesting them to immediately shut down the two **gambling dens** for the welfare of the residents of the village. From today, 11/12/2025, with the verbal permission of the IC of **Nadanghat Police Station**, Shri, **Biswabandhu Chattaraj** (+91 9147888565), **two additional gambling boards** have been added, bringing the total to four. Every night lots of people come here to play Andhar Bahar. **The whole night drunk players fight together and use bad language.** We are always harassed sir, it's a very bad message to our children. **Even after the evening, our children are scared to walk in our area.** We are **still surprised** that the **Nadanghat Police Station** did not stop the **Illegal Board** when lots of problems faced every village people. **Local Police know that seniors do not STOP them from doing anything they are doing illegally.**
