The **main illegal Satta gambling board handling office (Main Ghodi)**, Bansberia Narayantala, Near Ramkrishna clubhouse. Main Godi- Bansberia Narayan Tala, Near Ramkrishna clubhouse, The main illegal entity is notable among the **remaining branch offices (call Pad)** of the Satta Gambling Board. **Pencilor/Pad - around Tribeni Station, bus stand, Tribeni rail gate, Monosatala rail gate, Kathaltala, Kalitala over bridge, Township, 1,2,3, no gate, Palpara rail gate, Tissue Beltala bazar, around Kuntighat Station and Bazar, Mogra Natun gram, behind Mogra Krishna bar, Ramkrishna cinema hall, and around total Bansberia, Khejuria, Mithapukur, and Nandipukur.** The **main gambling Satta mastermind owner**, Mr. **Baidyanath Saha** (+91 6291759743 & 9073052837 & 7044369662 & 8100304419) & his partner, Mr. **Tubai Das** (+91 9681204707). **Since several Satta gambling boards are operating in railway areas like Tribeni, Bansberia, and Kuntighat, they also give 2 lakh monthly to the Railway CRPF.**

Presently, Mogra **PS Inspector Shri Dipankar Sarkar & CO, Mogra Shri Soumen Biswas** **take 9 lakh rupees monthly bribes** for operating this **illegal Satta gambling** board. Not only that, the owners of the Gambling board also **pay for the alcohol expenses** of the officers of the Mogra & Bansberia **police** station every night. How greedy and fearless is the **Mogra PS Inspector Shri Dipankar Sarkar & CO, Mogra Shri Soumen Biswas, only her own personal profit** gave **verbal permission** to run the illegal Satta gambling board.

Mamata Banerjee and the General President of the TMC All India Party, Shri Abhishek Banerjee, are corrupt, but the CBI and ED have always failed. But it is true that many police officers and influential people in various government positions continue to tarnish the image of current soccer to the public by repeatedly accepting bribes for their own interests. Hon'ble Chief Minister Smt. Mamata Banerjee has repeatedly held press conferences and clearly informed the police administration that she will not tolerate bribery at any cost, but unfortunately, some corrupt police officers are unable to refrain from accepting bribes.
