All Respected Sir & Madam CM of WB

We, all the residents of **Nabadwip**, are upset because for the past three years, some of our local people, **Mr. Mahadev Sen / Mr. Rajib Kundu / MR. Rampada Roy**, all of them have been running a large-scale illegal online gambling business. That is why all our youth and men are getting addicted to playing online gambling day after day. Over the past three years, many people have committed suicide after losing everything. Over the past three years, many of us have raised the issue with the Nabadwip Police In-charge **Shri Jaleswar Tewari**, Inspector of Police Nabadwip PS (WB), and Vice Chairman of the Nabadwip Municipality **Mr. Biman Krishna Saha**. But nobody takes any action. **On the contrary, Mr. Mahadev Sen, Mr. Rajib Kundu, and MR. Rampada Roy** their group attacked the complainant and threatened him that they were giving Rs. 25 lakh per month to the Police In-charge of Nabadwip Police Station Shri Jaleswar Tewari and Rs. 10 lakhs per month to the Vice Chairman of Nabadwip Municipality Shri Biman Krishna Saha, so if they opposed them, it would become difficult for them to live in Nabadwip. **We are disappointed that two responsible individuals have been implicated in a bribery scandal, so they do not consider any of our complaints to be serious. The Dak Babu of Nabadwip Police Station, Shri Abhay Debnath +91 9064530083, has been collecting all the illegal money on behalf of the Nabadwip Police In-charge, Shri Jaleswar Tewari, Inspector of Police (West Bengal).** Some prominent lawyers told us to specifically inform the Superintendent of Police Krishnanagar Nadia: **Shri Amarnath K (IPS)** and other **high-ranking officers** including the **CM**, after which they asked us to **file a case in court based on this letter**. We hope you will look into the matter seriously. We have mentioned the names of several people running the **IPL gambling panel**, who are fearlessly carrying out this work in their respective areas, namely **Mr. Mahadev Sen** (Buki

We are complaining also in the **vigilance department**, so please take action, the Nabadwip Police station officers in charge. **When our respected Chief Minister clearly said in front of the media that the police should not accept bribes from anyone, otherwise the Chief Minister would punish them, the police in charge of Nabadwip continued to accept bribes fearlessly.** Corrupt officers failed to maintain law and order in Nabadwip entire areas. We are almost 10 lakh people requesting to protect our village and town to save our youth lives. Some local TMC leaders support this type of illegal activity which reason already TMC party IMAGE is already being destroyed day by day. We are almost 10 lakh people requesting to protect our village and town to save our youth life. We hope that legal action will be taken on this corruption soon. Please ensure public safety as local police and some corrupt politicians are involved here because we suspect that if these are not properly stopped and severely punished, unrest may break out in the area. Please take action immediately, we are just hiding our identity because the local Police take huge monthly bribes to run the online illegal Gambling Board raked.

NOTE: For the last 30 days, we have submitted written complaints against this corruption to the SP of Krishnanagar **Shri Amarnath K (IPS)**, but no one has taken action against it, so we are forced to inform all the important higher authorities. On this day 22/05/25, the Nabadwip police arrested only two small online bookies. Two small bookies don't give monthly bribes timely, due to which the Inspector of Police of Nabadwip, Mr. Jaleswar Tewari, arrested them to clear his image and hide the borough bookies. Watch the video of the two arrested men happily getting into their cars and bailing the next day, **with the sole purpose of holding a video conference in front of the media** to show that they are conducting a borough raid. **Checkout FB Link**
