Honorable Madam CM and all respected officers last 3 years there are the **Illegal Big Gambling Boards** operating in under **Kotwali Police Station** area. Last 4 months, we have been continuously informed **Superintendent of Police, Krishnanagar: Shri Amarnath K, (IPS)**, but still now the SP hasn't taken any action against this corruption.

First illegal Gambaling Board Located Kalirhat Tata Showroom, behind **Ghosh Hotel opposite**, the **huge gambling board** is being run by Mr. **Biren** +91 7602895640 / **Sahajahan** +91 6294024770 / **Mithun Biswas** +91 6294192457 / **Shri Amalendu Biswas** 40% share (We have recorded the statements of all the board owners many times; they said that **Kotwali Thana Inspector Shri Amalendu Biswas** takes **40% profit** every day). That is ridiculous. **Kotwali Police Station Inspector Shri Amalendu Biswas** takes a 40% partnership in the **illegal gambling board**. **PC Party Officer Chintu Mahato** withdrew 40% of the money from the gambling board on behalf of **Kotwali Police Station Inspector Amlendu Biswas**. I have provided the audio recording of my gambling board owner as **proof**. Officers have already **crossed all limits of corruption**. **Kotwali Police Station Inspector Shri Amalendu Biswas** collects a **bribe of 5 lakh** every month from the gambling board in the name of **Dy.SP (IUCAW)**, Krishnanagar Police District: Smt. **Shilpi Paul** & Add. **Superintendent of Police (HQ)**, Krishnanagar: Shri. **Makwana Meetkumar Sanjaykumar (IPS)**.

Second The Illegal gambling board present location (already change old location Ghurni Lakshmi Bagan), now **Sondha Para, ward 3, Navodaya Club, near Saturn Temple**, inside the **Navodaya Club**, is run by Mr. **Subhash Das** (+91 6296168447/ 9002087098) / Mr. **Robi Shil** (+91 8918408842) Mr. **Sayan Mondol** (+91 6294444535) / Mr. **Mongal Pal** (+91 9239143907) / Mr. **Santos Mishtiri** (+91 9339638009) / Mr. **Swarup Adhikari** (+91 8942996818) / Mr. **Roni Sen** (+91 6295177609). Some people from the **Navodaya Club** oppose gambling, which is why the gambling board is now being moved 100 meters away from the front of the **Gopal Mandir** and the game is being played inside a **pandal**. **Kotwali PS Inspector Shri Amalendu Biswas** is taking a **monthly bribe of 5 lakh** for operating this illegal gambling board. Not only that, the owners of the Gambling board also **pay for the alcohol expenses** of the officers of the **Kotwali Police Station** every night. How greedy and fearless is the **Kotwali PS inspector Shri Amalendu Biswas**, only her own personal profit **gave verbal permission** to run the **illegal gambling board**.

Local people & BDO have **raised objections** many times to **Kotwali PS inspector Shri Amalendu Biswas**, but to no avail. Furthermore, they were **attacked** by the gambling owners' pet thugs. If you look into the matter, you will understand how **Kotwali PS inspector Shri Amalendu Biswas** has been

tarnishing the name of the **current government day after day for his own personal gain**. How **Kotwali PS Inspector Shri Amalendu Biswas** has **defamed the name of senior police** officers just for his own profit. **Shri Amarnath K, (IPS) Superintendent of Police**, Krishnanagar, his image is getting bad in the public eye because **Biren Biswas** +91 7602895640 / **Sahajahan Sheikh** +91 6294024770 / **Mithun Biswas** +91 6294192457 / Mr. **Subhash Das** & Mr. **Robi Shil** (+91 6296168447) / Mr. **Sayan Mondol** (+91 6294444535) / Mr. **Mongal Pal** (+91 9239143907) / Mr. **Santos Mishtiri** (+91 9339638009) / Mr. **Swarup Adhikari** (+91 8942996818) / Mr. **Roni Sen** (+91 6295177609) all the gambling board owner are surprising everyone by saying that we have to give bribes the **IUCAW & Add. NOTE: Now we are forced to inform the Supreme Court / Vigilance Commissioner / National Human Rights Commission / because the WB CID or DGP didn't take any action right now. Already informed of this allegation, Dy.SP (IUCAW), Krishnanagar Smt. Shilpi Paul, (+91 9147888318) / Additional SP (HQ), Krishnanagar Shri. Makwana Meetkumar Sanjaykumar, IPS (+91 9147888284), Superintendent of Police, Krishnanagar: Shri Amarnath K, IPS (+91 9147888283) and Kotwali PS Inspector Shri Amalendu Biswas (+91 9147888281), through WhatsApp, we are attaching the WhatsApp chat. Despite this, the **Gambling Board** continues to operate **fearlessly**, all **officials are silent**, because it is clear that they **cannot stop taking bribes**, they cannot live a luxurious life with just their salaries. **We never want to tarnish the reputation of senior police officers**, but after they were informed of everything via **What's App on 13/07/25, they are challenging us without looking into the matter**. They are so busy **taking bribes** that they have **forgotten** that there are **laws and regulations** in the country. **Honorable Chief Minister Smt. Mamata Banerjee** has repeatedly **held press conferences** and **clearly informed the police administration that she will not tolerate bribery at any cost**, but unfortunately, **some corrupt police officers are unable to refrain from accepting bribes**. But we are now **losing confidence in the current government's actions**. If the current government is so concerned about **police bribery**, then why is it not taking action even after submitting a written **complaint**? Just think about where the current government's image is going **in the eyes of the public**. We know that the country's **legal system is for everyone**, so we will highlight the issue more forcefully in front of the **entire judicial system** and the **media** of the country. The activities of the **corrupt police** will be **exposed** in front of all important departments every hour until the gambling boards are closed. For the past 3 years, many outside **criminals** have been coming to our area to gamble, **resulting in incidents of theft and robbery becoming a daily occurrence**. All the young men in the **village are becoming addicted** to this gambling addiction day by day and they are becoming completely destitute. **Many families are being destroyed by this gambling addiction**. The people of the village are afraid to go out after dark because there are many **criminal dens in our village**. We kept our identities secret because **Kotwali PS inspector Shri Amalendu Biswas** himself is taking huge sums of money from the gambling boards, the **protector has now become the eater**. We hope the present government will investigate the matter promptly and take the necessary **legal action (Find the attachment)**. We just want to live peacefully.
