Conditions of the Pet Sale:

THIS KITTEN/CAT IS SOLD FOR: PET ONLY, Ragdoll Jax is an EARLY SPAY AND NEUTER CATTERY.

This cat has been purchased as a pet. SELLER will spay or neuter this kitten/cat before it leaves with the BUYER. Kittens are usually spayed or neutered at around 14 weeks of age, and are normally ready to go home between 15 and 17 weeks of age (approximately 15 to 16 weeks for boys and 16 to 17 weeks for girls). This time frame can vary and may not be the same for every kitten. All spayed and neutered kittens will come with a TICA pet registration form.

PET BUYER INITIAL _____

Occasionally, a male kitten's testicles are not yet descended before it's of age to leave the cattery. This is the only instance where a pet kitten might not be altered leaving the cattery. In such case BUYER will be required to have the kitten neutered by contract: BUYER agrees that this cat must be neutered as soon as its testicles have descended, or at an age that a veterinarian deems appropriate if the testicles are retained. Pet registration papers will be withheld and will only be provided when BUYER provides veterinary proof of neuter to SELLER. Proof of neuter should include the cat's name and breed. SELLER will contact your veterinarian to confirm the breed and description of the cat that was neutered before providing TICA registration paperwork to BUYER. Proof of neuter must be provided to SELLER no later than when the kitten/cat turns 1 year old in order for BUTER to receive the TICA registration form SELLER. If no proof of neuter is provided by the time the cat turns one year old, no registration will be provided to the BUYER for this kitten.

PET BUYER INITIAL _____

Health Guarantee

If this kitten dies within 2 years of date of sale/delivery due to an inherited genetic disease, Purchaser must inform Seller in writing and provide a necropsy report from a licensed veterinarian. Seller will replace said kitten with another kitten of equal or lesser value selected by the Purchaser. All shipping costs and medical costs are the responsibility of the Purchaser. No refunds, discounts or credits will be given. This cat/kitten is guaranteed free of HCM and PKD, both parents have been tested and documentation will be provided. Please inform me if your cat/kitten develops any health issues.

Seller guarantees that this cat/kitten is healthy to the best of her knowledge. This cat/kitten is guaranteed for 72 hours against but not limited to the following ailments: upper respiratory infection, internal and external parasites, and against FELV / FIV. Purchaser has 72 hours to take the kitten to the veterinarian for a health exam. If any health concerns are found, the veterinarian's documentation must be provided, and the Purchaser can return the kitten to the Seller within seven (7) calendar days of the examination of the kitten. No medical or travel expenses will be refunded or credited on returned kittens and replacement kitten shipping is the responsibility of the Purchaser. During the first 72 hours the cat/kitten should be isolated from any other pets and monitored for health, eating, litter box usage, and activity level. The seller is not responsible for any injury or illness to other pets caused by exposure to it. Due to reactions we DO NOT recommend the vaccines: Chlamydia, FIP FeLV, Corona, Bordetella. Buyer understands that the seller reserves the right to cancel a sale even if a deposit has been made and the buyer's deposit will be refunded.

Other Pets Policy

"The seller is not responsible for any injury or illness to other pets caused by exposure to it."

If you have other pets, I suggest slowly introducing your new kitten to them. Keep a watchful eye to make sure they don't harm each other. During the first 72 hours the cat/kitten should be isolated from any other pets and monitored for health, eating, litter box usage, and activity level.

Re-homing Policy

"Under no circumstances will this cat/kitten be sold, leased, or given away to any pet store, animal shelter, research laboratory, breeding mill, or similar facility."

This policy is very important. DO NOT resell or give away your Ragdoll to any of these facilities. When you adopt a Ragdoll, you are adopting a forever friend. I do understand sometimes circumstances change and people must rehome their Ragdoll. Please contact me if you cannot find a good home. I will gladly help you find them a good home or take them myself.

Indoor Only Requirement

"This cat/kitten will be kept indoors and will not be allowed to roam freely outdoors."

Ragdolls are typically not fighters. They are best left inside due to a couple of breed-specific issues, including them being: Not particularly street-savvy. Prone to tummy upsets.

PET BUYER INITIAL _____

Declaw Policy

DO NOT declaw you cat/kitten. If you do, all health guarantees outlined above will be voided. BUYER will never allow children or other animals to harass, injure, or mishandle this kitten, and will make sure an adult is responsible for its care.
