All applications will be reviewed by the Leadership Lake County Board of Regents Selection Committee.

- Individuals who have demonstrated participation and contribution to the Lake County community
- Individuals who represent a cross-section of all facets of the community
- Individuals who will commit to a two (2) year involvement (as described below)
- **Applications must be submitted electronically. NO handwritten applications will be accepted.**
- **Three letters of reference from someone who is knowledgeable about your leadership performance and potential are required. - 1. Employer or Direct Supervisor, 2. Leadership Lake Alumni, and 3. Personal Reference**
- Please include a headshot with application

Program Commitments

Leadership Lake County requires a major time commitment from the participants, with full-day programs held 1-2 times a month for nine months (schedule below). Before you consider participation, we ask that you commit to attendance at LLC programs in their entirety and ensure that you, your employer and family are willing to make a two-year commitment.

Once an applicant has been accepted and has affirmed acceptance, tuition is **\$2,000.00. If paid by August 1, 2026 tuition will be discounted to \$1,500.00. Tuition is due and payable in full no later than September 15, 2026.** If tuition is not paid by the first class the tuition will go up to \$2500.00. All application withdrawals must be received 14 days in advance of first session for refund less \$50 processing fee.

To graduate from the Leadership Lake County program, participants must: (please initial each line)

_____ Attend a **MANDATORY OVERNIGHT** session. Failure to attend this session is automatic dismissal from the program. No exceptions. Dates are October 7, 2026 7:30am to October 8, 2026 4:00pm.

_____ **Mandatory Sessions-** Orientation (9/25/26), Overnight (10/7-10/8), Quality of Life (5/13/2027), Fundraiser (TBD by class), Graduation (October 2027).

_____ Attend all required sessions and conduct themselves in a professional manner. You will be given ample notification prior to each month's class as to the location (with directions) and start time.

_____ Complete two approved internships (different from participant's own industry). Each internship must be at least 4 hours in length. Participants are responsible for arranging their internships. **All internship paperwork is due by May 13, 2026.**

_____ *Participants missing more than two sessions will be immediately dismissed from the program. Upon dismissal, there is no appeal and no refund of tuition.*

Definition of Absence:

- *Absence of four (4) hours or more constitutes a full day.*
- *Absence of less than four (4) hours constitutes a half day.*

_____ Graduation for the Class of 2027 will be scheduled for **October 2027**. Family and friends are welcome.

_____ Commitment to participation after your class' Quality of Life Class Day - Evening Program and Dinner at Class of 2028's Overnight, Assistance with Class of 2028's Graduation, Fundraiser and Class Project if not already completed.

_____ Attend at least one alumni event after graduation outside of class committed days (above for committed days).
