

SB 426

would make a homeowner liable to any non-union construction worker who is not paid by the company that employs or contracted with the workers), even if the homeowner paid the employer. While everyone should be paid for their work, holding a homeowner who has acted in good faith and fulfilled their contractual obligation to pay for construction services liable for the failure of a contractor to pay their workers is fundamentally unfair.

Senate Bill 687

would roll back a state law – created when lawmakers took up transportation funding in 2009 – that requires cities to seek voter approval before passing local fuel taxes. It would also allow every county in Oregon to implement or hike vehicle registration fees without a vote, an option currently only available to the four counties with more than 350,000 residents.

HJR 8 – Imposes a statewide property tax to fund public safety.

H.J. Res. is the designation for a joint resolution that originates in the House of Representatives. A joint resolution is a legislative proposal that requires approval from both the House and the Senate.

Senate Bill 988

Permits a child's parent or guardian to admit the child, with or without the child's consent, to an inpatient treatment facility or program licensed by the Oregon Health Authority or the Department of Human Services for certain mental, emotional or behavioral health or substance use disorder treatment. Feb 6, 2025

Senate Bill 1089

The Oregon Legislature created the Universal Health Plan Governance Board with Senate Bill (SB) 1089 in 2023. The board is charged with developing a comprehensive plan to finance and administer a universal health plan, which is due to the legislature no later than Sept. 15, 2026.

Senate Bill 114

Requires the Legislative Revenue Officer to study the property tax system in this state. Directs the officer to submit a report to the interim committees of the Legislative Assembly related to revenue no later than September 15, 2026. Sunsets on January 2, 2027. Relating to the property tax system in Oregon.




