# INFORMATION SHEET

## - CAMP TUITION -

### **\*REGISTRATION RATES ARE \$370 PER WEEK\***

Only weekly registration is allowed. There are no individual days or drop-in registrations accepted. Our camper age range is 4-13.

### **- EARLY BIRD DISCOUNT (UNTIL 3/11/2026) -**

We are excited to be able to offer a robust Early Bird Discount. The discount gets increasingly better with each additional week in which you enroll. **Weekly rates increase and the discounts expire on 3/11/26 when the Standard Registration period begins.**

<b>All 7 Weeks</b>	= \$280 discount off of total tuition fees
<b>6 total Weeks</b>	= \$205 discount off of total tuition fees
<b>5 total Weeks</b>	= \$150 discount off of total tuition fees
<b>4 total Weeks</b>	= \$100 discount off of total tuition fees
<b>3 total Weeks</b>	= \$60 discount off of total tuition fees
<b>2 total Weeks</b>	= \$25 discount off of total tuition fees

### **- SIBLING DISCOUNT -**

Take \$50 off of each week for each additional sibling. We are grateful to be able to help the families who are raising multiple children. Please reach out to Coach Russell if you need help calculating the discounts. (805) 338-0231

### **- CASH DISCOUNT -**

We offer a cash discount that is based on the total number of weeks that you enroll in and is only offered for a limited time. Please inquire at (805) 338-0231 or email KidsInMotion805@gmail.com.

### **- IMPORTANT INFORMATION -**

- Drop off and pick up will always be at St. Patrick's Day School - 1 Church Rd. Thousand Oaks, CA 91362
- Each day, campers should wear active clothing and shoes – i.e. athletic (closed-toed) shoes, t-shirts, shorts, and possibly a hat.
- Campers must bring a backpack to camp so they can keep all their belongings together and protected.
- Bring water stuff in your backpack on Tuesdays and Thursdays: *sandals, towel, bathing suit, and water shirts (highly recommended).*
- Campers MUST bring a refillable water bottle every day. We have two cold, filtered water refilling stations available.
- Other useful items include: spray sunscreen and some money for the Camp Store (optional).
- Campers are allowed to bring Pokémon and sports cards so long as they keep them in a binder or box in their backpack when not in use.

### **- CANCELLATION POLICY -**

We require 21 days of notice in order to cancel weeks. Individual days cannot be cancelled. There will be a **15% administrative fee** reduced from the refund to account for the additional administrative work necessitated by the request. **We do not allow any cancellations after camp begins on 6/8/2026.** There will be no refunds in the rare instance of any behavior or disciplinary reasons. There will be no exceptions to these rules.

### **- POLICY FOR SWITCHING WEEKS -**

We can try to accommodate switched weeks but can only do so if that week is not already full. There will, however, be a \$25 **change fee** per changed week per child to account for the additional administrative work. There will be no exceptions to this rule.

### **- POLICY FOR MISSED DAYS -**

**Due to our weekly registration system, we are unable to provide credit or refunds for individual missed days of camp.** If your child is sick, please do not send them to camp and let Coach Russell know that they will not be attending camp that day.

### **- DAYCARE PROGRAM -**

**Daycare runs from 7:30-9:00am and 3-6:00pm in the Daycare Room. \$10 per hour (\$2.5 for every 15 minutes) per camper.**

Daycare spots are limited this year and should be registered and paid for ahead of time using the Daycare form on page 7. The earliest drop off time is 7:30am and the latest pick-up time is 6:00pm. The program will be lots of fun but less structured than the rest of the camp day. Kids will be able to play on the playground, use some free-play equipment, do simple arts & crafts, read books, play board-games, or watch the occasional family-friendly movie. **Parents arriving after 6pm shall be charged \$5 per 10 minutes late to account for staffing costs.**

### **- THE CAMP STORE -**

The Camp Store will have optional drinks, snacks, treats, and small toys for sale for a nominal fee. Please send a few dollars with your camper if you so choose. The Camp Store only accepts cash and will be open during snack-time and lunch. Campers will only be allowed to make one visit each time. This part of the program is 100% optional.

### **- WATER TUESDAYS AND THURSDAYS -**

We added an additional water day to each week! We will play water games, use water guns, and/or have a water attraction every Tuesday and Thursday. Please wear active wear and closed-toed shoes to camp. Please bring: *sandals or water shoes, a towel, spray sunscreen, and a bathing suit in your backpack. Water shirts (i.e. rash guards) are highly recommended for sun protection.*

**- OPTIONAL LUNCHES (ORDER ON PAGE 6) -**

**- PIZZA OR HOT DOG MONDAYS -**

Every Monday we will have slices of Cheese or Pepperoni Pizza or Hot Dogs available from Costco for \$3 each.



**- TACO TUESDAYS -**



On Tuesdays, we will have Crunchy or Soft Tacos (with beef, lettuce, and cheese), Chicken Quesadillas (flour tortilla flatbread, cheese, & chicken), or Bean and Cheese Burritos (with no red sauce or onions) from Taco Bell for \$4 each. Taco sauce packets will be available on the side.

**- CHICK-FIL-A WEDNESDAYS -**

On Wednesdays we will have a meal from Chick-fil-A consisting of 7 Chicken Nuggets and a side of Fresh Fruit (apples, mandarin oranges, strawberries, & blueberries) for \$13. Various dipping sauces will be available on the side.



**- THE STAND THURSDAYS -**



On Thursdays, we are pleased to offer lunch from The Stand, featuring a choice between a complete boxed meal or a standalone hot dog. The meals are available for \$13 and include your choice of a Chicken Sandwich, Turkey Sandwich, or Grilled Cheese, accompanied by chips, apple slices, and a chocolate chip cookie. The meat sandwiches are prepared with meat and American cheese on a bun, while the grilled cheese features American cheese on a brioche bun, with all vegetables and condiments served on the side. For those looking for a smaller portion, a Hot Dog is also available for \$8.

**- AMECI PIZZA FRIDAYS -**

Each Friday we will have slices of Cheese or Pepperoni Pizza from locally-owned favorite, Ameci Pizza, for \$3 per slice.



**- ELECTRONIC PAYMENT OPTIONS -**

We accept **ZELLE, VENMO, CASH APP, and \*PAPYPAL** electronic payments. Zelle is preferred as there are no extra fees. **Scan one of the QR codes below** or send Venmo or Cash App payments to username: **COACHBRANDONRUSSELL**. There is a 5% charge on top of the grand total for all payments made by card. All transactions are processed manually and the form is immediately shredded afterwards. # KIDS IN MOTION LLC – CAMP WAIVER AND RELEASE OF LIABILITY (MINOR PARTICIPANT)



I, the undersigned parent or legal guardian of the minor child named below, hereby give my full authorization for my child to participate in Camp Kids In Motion, which is operated by Kids In Motion LLC and hosted at St. Patrick’s Episcopal Church and Day School. Camp activities may include, but are not limited to, running, jumping, climbing, sliding, ball games, athletic sports, tumbling, archery, and other physical recreational activities commonly associated with youth sports camps. I certify that my child is in good health and physically able to participate in the activities described above. I understand that it is my responsibility to consult a physician prior to my child’s participation if I have any concerns about their health or readiness. I understand the nature of the physical activities for which I am registering my child, and in consideration for my child being permitted by Kids In Motion LLC and St. Patrick’s Episcopal Church and Day School to participate, I hereby voluntarily waive, release, and discharge any and all claims for damages for personal injury, illness, or property damage which I may have, or which may hereafter accrue to me or my child, as a result of participation in the program. This release is intended to discharge in advance Kids In Motion LLC, St. Patrick’s Episcopal Church and Day School, and each of their respective owners, directors, officers, employees, contractors, representatives, agents, and volunteers from any and all liability arising out of or connected in any way with my child’s participation in the camp activities—even if such liability arises from negligence on the part of any of the released parties. I understand and expressly agree that this release includes claims based on the ordinary negligence of the released parties and covers any bodily injury (including death), illness (including communicable diseases), or property damage resulting from such negligence. I acknowledge that participation in physical camp activities involves inherent risks, including the risk of serious injury or accident, and I voluntarily assume all such risks on behalf of my child. It is further agreed that this waiver, release, and assumption of risk shall be binding on me, my child, our heirs, assigns, and legal representatives. I further agree to indemnify, defend, and hold harmless Kids In Motion LLC, St. Patrick’s Episcopal Church and Day School, and their respective owners, directors, officers, employees, agents, contractors, and volunteers from any and all claims, demands, actions, losses, liabilities, damages, costs, or expenses (including reasonable attorney’s fees) arising out of or related to my child’s participation in the program, including any claims brought by third parties. I authorize Kids In Motion LLC and its representatives to arrange for emergency medical treatment for my child if necessary. I understand and agree that I will be financially responsible for any medical care or treatment provided. This agreement shall be governed by and construed in accordance with the laws of the State of California. If any provision of this agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
