

ATAB Active Shooter Active / Assailant Program

To establish a comprehensive Active Shooter or Active Assailant program for your business will require training in several modules to address each training discipline.

Company and Staff Education and Planning:

This section provides an overview of what an Active Shooter Program is and what is required to establish your program starting with your company policy manual, employee briefing on what to do during a drill and what to do during an actual incident. Additionally, you will have programs on tabletop drills and actual hands on practical exercises.

Various Risk and Threats to your business:

We then move to the Workplace Violence program. There is a much great chance of the shooter being married to one of the victims or having been an employee. The next step is Behavioral Analysis so that they know what suspicious behavior is. Profiling of violent offenders. We then address Stalkers and their characteristics.

Assailant Survival and Response:

Training classes to provide a strong understanding of who, why and how we then provide a program following the DHS guidelines of Run, Hide and Fight as well as the ATAB programs that have been developed by ATAB Members with years of experience dealing with Active Assailants. Programs designed to instruct your employees or staff in what they should do in an active shooter or assailant situation. This program is designed to follow the corporate policies of companies that do not allow firearms in the building or do not condone the thought of actually hurting the attacker.

Responder Training and Crisis Management

The ATAB program has specific training for Active Shooter Response (for LEO,s and Security) then a program on Active Shooter Crisis Management. This program is designed to provide training in tactics and actions that should be taken by your response team.

The next program is Active Shooter the Truth. It is not the politically correct version. It addresses tactical methods for stopping an active shooter and methods to utilize your personal carry weapon to extract yourself from an active shooter incident where you are being attacked by individuals with greater firepower than your pistol.

The portion that is for LEO's with drills is a 2-day program. If you do not use that portion and it is for business staff and employees, you have a good solid 1-day class that addresses every aspect of Active Shooters. If utilizing some hands-on work with the students on disarming techniques and some basic unarmed defense this will be a two-day program.

First Aid and Medical Response for non-medical people:

We are not doctors or medical instructors but we have several power points on emergency medical and tactical medicine. Our high-risk medical programs provide information on what works in saving lives in gunshot or knife attack situations. Covered in the programs are what emergency first aid items you should have on hand and how to stage them around your facility to provide the best coverage for your people.

Corporate Liability in Training:

You have to remember that if you are teaching to employees that you do not teach them anything that could result in litigation at a later date. There was a case in Atlanta Georgia where a company had a female police officer come in and teach a Rape Survival course. The police officer made extra income by selling Chemical Agents such as Pepper Spray or Mace. One of the things that she taught them was that they could put their keys between their fingers and punch the attacker in the eyes. Two weeks later two of the women who worked in the business got into a fight over a man with a coworker and the one woman blinded the other with her car keys.

The victim sued the company for bringing the police officer in to teach them how to cripple someone. They sued the officer personally for improper training.

While anyone can sue for anything, we go to great lengths to ensure that our materials limit your exposure to litigation by providing industry best practice materials and standards.

While there are a lot of things that we may teach police or soldiers when you train non-military you have to keep in mind that the corporate world is mostly run by people that avoided military service. They may smile and say Vets are heroes but deep down many do not like what we do or what we stand for. They have watched so many Law and Order shows where the military vet comes back with PTSD and kills or rapes someone deep down, they do not want us around.
