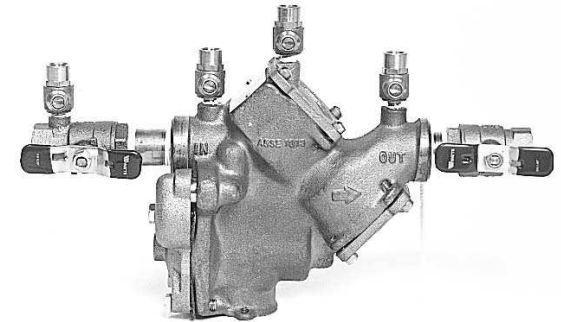


Backflow Tester Recertification
\$275 Member / \$300 Non-Member
(this fee includes \$75 sent to the state of
Ohio to Renew your license)

- This is an 8 hour course with a practical and written test given by the Training Agency.
- License is renewed for 3 years.
- You may recertify up to 11 months before expiration and it will add 3 years to your expiration date.
- An expired Backflow Certification can be recertified by taking an 8 hour recertification class up to the 3rd year of expiration. Fees are prorated \$25 per expired year plus \$75 for recertification to renew license at the State of Ohio.
- A Backflow Certification that is expired 3 years or more will be required to repeat the entire Backflow Training Course through an approved Training Agency. All fees will be active. Requirements will be: Submitting a Backflow Application and appropriate fees to the State of Ohio, Approval of such application, Required 24 hours of Backflow training, Passing of the DOC Backflow Exam, Upon passing the exam submitting the \$75.00 – 3 year certification fee.

Information, Class Dates & Registration

Backflow Tester Certification \$400 Member / \$425 Non-Member

- This is a 24 hour course with a practical test given by the Training Agency and a written test given by Ohio DOC (Department of Commerce).
- Prior to registering with CMPA for the classroom training, you must submit an application to the Ohio Department of Commerce Backflow Division for approval. Form can be found at the Ohio DOC's website, under forms for Plumbing & Backflow (Form # 3104). **Ohio requires at least 5 years minimum experience and employment with a Plumbing, Hydronics, Fire Sprinkler Contractor or Water Purveyor.**
- Once you receive your application is approved, you may register for the class by submitting registration and a copy of your approved application.
- The written test is given the 3rd Monday of each month at 6606 Tussing Road, Reynoldsburg, OH. The doors open at 9:30 a.m. with the test beginning at 10:00 a.m and ending around Noon.
- Student must bring to the written test: Original application, Certificate of Proficiency (provided by training agency) and a photo id.

Rules of a State of Ohio Backflow Tester

FALSIFICATION OF RECORDS:

- If an Ohio Department of Commerce backflow certificate holder is found to have falsified test report documents penalties will be enforced as outlined.
- Falsification of records includes, but is not limited to:
 1. Claiming to have tested devices that were not tested.
 2. Signing off on tests that an uncertified person has conducted.
 3. Fixing devices without testing them.

PENALTIES FOR FALSIFICATION:

1st Offense: Backflow certificate will be suspended for 6 months. All Health Departments, Building Departments, and Water Purveyors will be notified of the suspension either by mail or via the Internet.

2nd Offense: Backflow certificate will be suspended for 2 years. All Health Departments, Building Departments, and Water Purveyors will be notified of the suspension either by mail or via the Internet.

3rd Offense: Certificate holder will be terminated from the Backflow program for Life.
