2018 OOCIA Board Accomplishments & 2019 Action Plan

Your Olde Oaks Community Improvement Association (CIA) worked diligently during 2018 to maintain the common areas of the Association and provide community services while keeping a close eye on the expenses. The CIA took the following actions in 2018:

- The newly upgraded website OOCIA.org is now up and live! Please let us know if there is anything you feel should be added to the site to better help our community by contacting Treasurer@OOCIA.org. The upgrade will save OOCIA close to \$9,500 over the next five-year period! This was exciting to help lower our costs.
- The CIA negotiated contributions from MUD 20 and MUD 44 for maintenance of the TC Jester medians for a total of \$50,000. We appreciate their contributions in helping to keep our community beautiful. Thank you, MUD 20 and MUD 44!
- The CIA has developed an investment plan for its Reserve Funds to greatly improve the return on investment for this account. Crest is improving our interest returns for the operating accounts to receive higher interest rates, as well.
- The landscape and mosquito contracts were sent out for bid to make sure that the Association was getting the best service for the best price available.
- The kiddie cushion at the Kennonview Drive Park was filled back in after the Harvey flooding.

- MUD 44 required testing of the back-flow prevention devices on the HOA's irrigation system. This was completed and needed repairs were made.
- Texas Pride advised the CIA of an increase in recycling cost, and the CIA used this to negotiate an amendment to the contract so that the contract is transferable. (See following paragraph for more info on this.)
- The CIA engaged with a new attorney which has resulted in a decrease in the amount of delinquent assessments and provides more precise legal information for each delinquent account. We are very pleased with the negotiations for payments on many large and very delinquent accounts. A great success for OOCIA!

You may have noticed a change in the annual billing which you received recently. With the engagement of a new law firm, the CIA was advised that it needs to separate the assessment and service fees on the annual billing. Currently, the only service which is being billed is the trash service. In 2019, the CIA will attempt to negotiate with the various MUDs that service our community to transfer this service to their responsibility in 2020. This means your trash service will be billed along with your water bill each month, spreading your expenses out into monthly payments rather than needing to pay for the full year upfront.

Our highest priorities for 2019 will continue to be the enforcement of deed restrictions, adherence to architectural guidelines, and to keep chipping away at our outstanding past due accounts. The past due receivables amounts have been quite large for many years, and the past two Boards have worked aggressively at getting money collected to reduce this number. This past year, the community had numerous bankruptcies and foreclosures that affected our outstanding accounts receivables. The new law firm is working diligently and aggressively (with great success!) at reducing our overall balances. Please keep in mind that with foreclosures and bankruptcies, we can only hope to recoup past funds owed, as there are no guarantees that repayment will be released to us from the lenders and bankruptcy courts. The Board is quite pleased with the results of the new law firm as they have successfully received repayment agreements with several very old and substantial accounts. And they have really only just begun!

Please welcome our **new** (but not new to OOCIA) Crest Association Manager Pam Hummel! Pam has been Karen Janczak's assistant manager in the past and she is very familiar with our community. Pam and her assistant are the Crest team that encouraged our neighborhood to identify any deed restriction issues that need to be addressed. She is a great person to work with, and we look forward to her helping keep our community safe and beautiful! Her contact information is: pam.hummel@crest-management.com.



Book Club "Footnotes"

Happy New Year to you all! We in the book club look forward to some new books and authors in this new year. In late November, we chose the books for January through May.

January – *Pachinko* by Min Jin Lee

February – *The Wife* by Meg Wolitzer

March – *Bluebird, Bluebird* by Attica Locke

April – *The Restless Wave* by John McCain

May – *The Whippoorwill* by Mary Bryan Stafford

On **January 22**, we will meet at the home of Randee Saber, and Jerry Lutz will lead the discussion. The book, *Pachinko*, is an historical novel by Korean-American author, Min Jin Lee. It follows four generations of a Korean family who first lived in Japanese-occupied Korea and eventually migrated to Japan. The story covers the period before World War II to the late 1980s.

Pachinko is perhaps an odd name to many of us. It is a slot machine game found throughout Japan and "unifies the central concerns of identity, homeland, and belonging in the Japanese culture according to a New York Times book reviewer. Min Jin Lee was born in Seoul, Korea and educated in the United States. Although a lawyer, she quit the profession and found bargain opportunities to pursue a literary career. It was difficult with money, health, and family issues, but she persisted. Her first two books were not successful, but she followed up with *Pachinko* which was published in February 2018.
