No Kid Sleeps on the Floor in Our Town

Longtime Olde Oaks residents Gary and Nikki Akin have established a local chapter of Sleep in Heavenly Peace (SHP), a non-profit, volunteer organization that builds cargo-style beds for children who have none. The twin beds (either as a bunk or single), given free, are delivered and assembled and include all new bedding.

Components for the beds are built at the SHP shop on the property of TheMET Church located on Jones Road. Volunteers from the community are needed for Build Days. Businesses, organizations and/or groups are needed to sponsor a Build Day and provide volunteers.

Drop off checks or mail them to: 3219 Chapel Bend Dr. They will be mailed to SHP headquarters in Kimberly, ID with the designation that they go into the account of our local chapter. **New** twin bedding (twin sheet sets, coordinated flat and fitted sheets and pillowcases, vinyl mattress covers, pillows, comforters, five- or six-piece "beds in a bag") is where we all can help.

At the August Monthly Board Meeting, the following issues were discussed in the Open Forum:

- A request to postpone the newsletter publishing date in an effort to provide more timely information; particularly financial information. The deadlines are controlled by the publishing company, Champions Printing & Publishing. Crest Management agreed to follow up with this to see if postponement is possible.
- A request was made for communication to the community regarding the change in contracted legal services.

- An observation that communication about Board activities, in general, could be improved; frustration with understanding whether our community prefers relying on the newsletter, the OOCIA website or Nextdoor. The Board expressed its hope that interested parties would attend the monthly Board meetings on a regular basis.
- Brief discussion regarding the Board's interest in moving responsibility for contracting trash collection services to the three municipal utility districts. This would relieve the OOCIA from carrying accounts receivable balances and attempting collection on the portion of the annual assessment attributed to this service.
- A detailed discussion of the upcoming Bammel Municipal Utility bond referendum and why it is important for our neighborhood to be informed about recent property annexations adjacent to Olde Oaks. As a result, Board members agreed to attend September meetings of the utility district boards.



Protect Your Home Investment

Our homes are investments and, in some cases, the only investment a homeowner may have. There are Deed Restrictions and Architectural Standards and Guidelines that are in place to help maintain the appearance of our subdivision. The Architectural Control Committee (ACC) is made up of qualified volunteers who reside in our subdivision and give their time to see that your investment maintains its value.

Homeowners planning to make improvements to the exterior of their home or elsewhere on the property must obtain written approval **prior** to beginning work from the ACC. This includes painting and repainting of siding, trim, brick, front door, etc. The goal of the ACC is to serve both you and the community by determining that your finished improvement will comply with the Deed Restrictions and Architectural Guidelines and enhance the value of your property and our neighborhood. Approval is not required for plans to remodel, paint, or otherwise alter the interior of a home.

While the ACC tries to make a decision within several days of receiving a request, the turnaround can be up to 30 days from the date or receipt by the committee. Please do not wait until the week before your painters are to begin work to submit your application! After receiving your application, Crest Management documents the receipt of it and then forwards it to the committee for review. ACC requests may be submitted online by going to <http://oocia.org/architectural-control> and clicking on the link for the online application form. Pearl Fincher Museum Prepares for First Exhibition Since Hurricane Harvey

As the Pearl Fincher Museum of Fine Arts prepares for its long-awaited re-opening after Hurricane Harvey, its first exhibition will be selections from the Chip Hosek Collection of American Art.

An American View Revisited: The Hosek Collection of American Art is the second opportunity the Pearl has had to showcase the extensive pieces of Pearland collector Howard (Chip) Hosek, Jr. Originally exhibited at the Pearl in the fall of 2009, the Hosek Collection has continued to expand as he has passionately sought to purchase works of art that hold

interest to him, especially ones that present the American story. The Hosek Collection initially concentrated on American art from 1850 – 1950, but has now grown to include works from the late 20th century as well as the 21st century.

Highlighted in the exhibition are works from four members of America's important family of artists: The Wyeth Family, including N.C. Wyeth, Andrew Wyeth, Jamie Wyeth and Henriette Wyeth Hurd. Additional pieces by Norman Rockwell, Andy Warhol and numerous other American artists are represented in more than 50 outstanding works that will be featured in this exhibition.






