

Please treat your neighbors with the respect you would like shown to you. The Sheriff's deputies can cite you for blocking access to mailboxes or driveways or for vehicles with expired tags.

## CenterPoint Delivery Charges for Electricity

CenterPoint delivery rates historically change twice a year; in March they typically decrease and in September they typically increase. Effective March 1, the delivery charge from CenterPoint decreased by \$.01354/kWh to a rate of \$4.39 per month and 3.5620 cents per kWh. Delivery charges for your home are the same without regard to which retail energy provider you choose.

## **Book Club Footnotes**

This month we'll meet on April 25 at the home of Randee Saber. We'll discuss a current bestseller, *Mad Honey*, by Jodi Picoult and Professor Jennifer Finney Boylan. Bee keeping figures in this book and there are even a few recipes in the back of the book made with honey.

Olivia McAfee, a beekeeper, relocates from the west coast to New Hampshire with her teen-aged son, Asher, after a failed marriage. Another woman and her daughter, Lily, relocate from California to the same town in New Hampshire for a fresh start. Their paths cross, the teens meet in school, and fall in love. One day Lily is found dead at the bottom of the stairs in her house. Asher finds her but is arrested on suspicion of murder. There is much that has been hidden about her gender and their relationship, but much is revealed at Asher's trial. Interspersed in the story is fascinating information about bees and beekeeping, Olivia's livelihood.

Jodi Picoult is an award-winning author of 28 novels that many of you no doubt are familiar with. Many have been made into movies and musicals. She lives in New Hampshire. Prof. Boylan is also a best-selling author of many books and is a nationally-known advocate for human rights. She teaches at Columbia and Harvard Universities. Her memoir, *She's Not There: A Life in Two Genders,* was the first best-selling work by a transgender American. She lives in New York City and Maine.

You ask how they were able to co-write a book? They did so during the pandemic and utilized Zoom. Ms. Picoult had been thinking about writing a book on transgender rights for some time and co-authoring was an interest of hers. Prof. Boylan had read some of the other's books and had dreamed about a book with the *Mad Honey* plot. They messaged each other and subsequently decided to "do it."

## Home Safety

## Some suggestions for improving safety in your home include:

#### **Prevent Fires**

- Prevent cooking fires. Stay in the kitchen when frying, grilling or broiling food. If you must leave the kitchen, consider turning off the burner or stove as a security precaution. Always keep an oven mitt and pan lid nearby when cooking. If a small fire starts, put the lid on and turn off the burner. Don't try to move a burning pan, as that could fan the flames and spread the fire. Don't pour water on a grease fire because it can make the fire spread.
- In case of an oven or microwave fire, turn the appliance off and keep the door closed.
- Add a fire extinguisher. Follow instructions and stand back 6-8 feet. Be careful not to spray the grease out of a pan, as that may cause the fire to spread. A fire extinguisher is only effective if it's maintained properly. At least once per year, you should verify that it hasn't expired and ensure that the safety pin remains intact and make sure that the nozzle still works. You'll need to replace the extinguisher every 10-12 years.
- Install a smoke alarm and carbon monoxide detector. Don't disable the smoke alarm by taking out the batteries. You can buy a smoke alarm with a pause/hush button to temporarily stop the noise. Test your smoke and carbon monoxide detectors at least annually. The US Fire Administration recommends testing your batteries monthly and replacing them once or twice per year; some people replace the batteries when the Daylight Savings time changes. You should also swap out the entire device every 10 years.
- Grill outside at least three feet away from your home.
- Have your chimney and flue checked out to make sure there isn't any soot buildup. You can get a cover put on top to keep birds and other creatures out of your chimney.

If you decide to fight a fire (not recommended), be sure everyone else is out of the house and that you have a clear path to safety. Call 911 or ask them to call just in case.

#### **Eliminate Tripping Hazards**

- Buy non-skid rigs for the bathroom and use nonslip treads or a mat inside the tub or shower.
- Throw rugs need to be tacked down with double-sided tape or carpet tacks.
- Check to make sure electrical or phone cords are not a tripping danger. Make sure the furniture is arranged so there are clear pathways to walk.

#### Improve Lighting

- Install bright bulbs inside the fixtures in the home and possibly add supplemental lighting if necessary.
- Consider purchasing dusk to dawn nightlights in the bathroom and hallways that light up after the sun sets.
- Mount some motion sensor lights outside at both the front and back doors and driveway that automatically come on.

## Have Grab Bars Installed in Bathrooms and Showers

- Have wall mounted bars installed into the wall studs. It's best to choose bars with surfaces that are slightly textured that are easier to grip. These can prevent falls and can assist if the person has difficulty getting up after falling.
- Install railings on stairs. Help prevent falls on steps by installing a railing that is anchored to the wall studs (it must be attached to the studs, otherwise it will rip right through the wall board).

#### **Home Security Measures**

• When it comes to keeping your family and your home safe, break-ins, theft and vandalism may also pose significant risks. Consider investing in a whole home security system or one or two security devices, such as a door bell or security camera and motion detector lights.






## Monarch Chamber Players Performance


