# 2022 OVERVIEW

On behalf of the NSMH Legacy Fund, we extend our sincere thanks to all the donors and contributors for your generous support. A total of \$24,673 was raised in 2022 from 25 individual donors.

In 2022, The NSMH Legacy Fund continued to invest in the NSMH/HBCU Leadership Institute to support the development of NSMH students who are a part of the HBCU – Hospitality Consortium. Two grants were made for a total of \$16,900 to support the NSMH/HBCU Leadership Institute. This support provided 17 NSMH students from 6 Historically Black Colleges and Universities (HBCUs) with activities and lessons to sharpen their professional brand, time management skills, public speaking abilities, and networking opportunities. One of the noteworthy outcomes of the Institute is that it yielded new leadership at the chapter and national levels including national chairs for two years in a row.

I'm also pleased to share that the NSMH/HBCU Leadership Institute is run by a Cornell Hotel School alumna Dr. Sharonda Bishop, a former NSMH National Chairperson. This effort is also supported by Dr. Berkita Bradford from Delaware State University who serves as Chair of the HBCU Hospitality Consortium.

As the NSMH Legacy Fund seeks to complete its campaign goal of \$250,000 in the upcoming year, we hope you will continue giving generously to help us reach this important milestone. Your financial support makes a difference and will allow us to continue to have a meaningful impact on NSMH and its mission to advance minority students in the Hospitality Industry.

I also want to extend a special thank you to the NSMH Legacy Fund Executive Committee. These volunteers are true community champions and have a deep commitment to maintaining the legacy and vision of the National Society of Minorities in Hospitality (NSMH). We are also grateful to the leadership of the NSMH National Board and National Advisory Board for their continued passion for advancing minorities in hospitality.
