President's remarks

Previous minutes

Treasurer's report

Bank balances as of meeting date:

Late fees – Ody received calls from 10 people who said they did not get second notice – 2 notices were wrongly sent to people who had already paid – discussion of THR Property Management who own 3 properties in the community & pay weird amounts – often quarterly – Ody & Mo need to look back in prior Treasurer's records regarding payments for these properties & monies due. Ledger of unpaid properties cannot be sent to attorney yet as it has not been 30 days since last notice was sent - JP plans to introduce himself to association attorneys in coming weeks

2026 Budget discussion

2026 proposed budget needs to be finalized & distributed to the community (by email or mail) along with quarterly meeting notification prior to the in-person quarterly meeting in January. Typically the board holds a couple of meetings to determine & agree on the budget in December & early January. Lots of discussion about availability to meet since Tuesdays are bad for Ody who needs to be present for a budget meeting. First budget review meeting now scheduled for 15th December at 7:30pm by Zoom – a second budget review meeting tentatively planned for Monday 5th January. The in-person January quarterly meeting is currently scheduled for 27th January at Fire Station Community Room – date may be revised based on availability of meeting room on nights other than Tuesdays

Note: Ody will need a list of all vendors we deal with for budget preparation – such as electrical, fence repair, PanAmerican, Town of Davie (police patrols/meeting room), storage unit, mail box, holiday lights, etc...
