Meeting began at: 9:58 am

- **Motion to approve prior minutes:** Jim 1st, Walt 2nd, vote unanimous
- **Action Items**
 - **Bill: Resolve dates between ORNSCA and ScoreChasers for Richardo shoot**
 - **Jim: Confirm Boy scout shoot**
 - **Jim: Received \$2000 budget for facility and target system repairs and supplies**
 - **Jim: Receive authorization to acquire four Type4 Controllers for target system**
 - **Walt received \$2000 budget for 5 stand repairs**

 - Silent Auction

 - Shotgun start
 - 50 people = 4 person squads @ all stations
 - 84 people = 6 person squads @ all stations
 - Prep-registration to allow us to monitor headcount
 - Will need all local member at each station to pull and explain station specifics
- **President (Aaron)**
 - N/A
- **Vice President (Bill Sumners)**
 - Bill says resolution of the NSSA fees is complete. Craig gave Bill a copy of the last email thread that suggests it may not be. Craig will double confirm with Lori just to be sure we're in good standing.
 - Bill reported that the Richardo Memorial Shoot is registered
 - Note: After meeting it was discovered that ORNSCA and ScoreChasers have different dates posted. Need to resolve asap.
 - Boy scout Shoot is tentatively schedule for 9/5 but we have not heard confirmation. Jim will confirm.
- **Treasurer Update (Chuck)**
 - All July Expenses turned in to Chuck
 - June: \$1592 shooter income, \$366 expenses
 - JCSA has not provided \$1800 of funds from card sales at front desk: 2025 Mar \$300, Apr \$300, May \$600, Jun \$600
 - These amounts have been added into the spread sheet under Front Desk Card Sales and added into the JCSA ledger account
 - Online financial data was reviewed

- **Secretary Update (Craig)**
 - Saturday Trap Shoot events, which we post on our calendar, to be updated to 9:30am until weather is too cold for morning shoots

 - An email was sent to Craig Bain requesting details for candidate submission to JCSA board. No response received, but JCSA sent a general email to all members the next day with an email to use for submitting names.

 - Walt made several suggestions regarding facility improvements needed:
 - Florence shooters suggest we change the course more often as they shoot here a lot
 - Walt pointed out information related to the Edward Jones account profile and shared his thoughts related to the funds
 - 5 stand improvements
 - Signage improvements
 - Painting to various areas
 - Add shipping containers to make storage and movement of inventory more efficient
 - Add woodstove to clubhouse before winter
 - Create sandwich boards for directing visitors

 - Batteries working great now that sun is shining
 - Motion (Bill) to allocate \$2000 budget to Jim for facility and target system repairs. Chris 2nd. Passed unanimously
 - Motion (Craig) to authorize Jim to acquire four Type4 controllers for the target system. Walk 2nd. Passed unanimously
 - Motion made (Jim) to provide Walt \$2000 budget to paint and improve 5 stand area and others items as determined by Walt. Craig 2nd. Passed unanimously.
