Board Member 2024-2025 Elections

Election proceedings began with secretary, Craig Lassen reviewing the Article V section below,
specifically that board members will be determined by a simple majority vote of members present.

ARTICLE V, OFFICERS

The officers of the Rogue Valley Sporting Clays shall consist of a President, Vice-President, Secretary, Treasurer, or Secretary/Treasurer, Course Manager and 2 Directors to JCSA and shall be elected by a majority vote of the membership in attendance and shall work with the previous year's officers for the month of August.

The newly elected officers will learn the duties of the office position they have accepted, and review policies and procedures for the running of the Club and to establish a budget for the next year. The fiscal budget will be based on calendar year of January 1_{st} until the following January 1_{st} .

The new officers will be installed at the August General Election Meeting to serve for one year. The new Board shall assume the operating budget in place by previous Board until the new budget is proposed at the January General Membership meeting.

- Evaluation: Shooting stations were all broken, doors were not opening on trap houses, bird boxes were deteriorated from water damage, rodent infestation, controls not functioning. A new long-range wireless system would need to be replaced at ~\$11k (Controller w 8 receivers \$8k, 3 more machines at \$3k each).
- Outcome: Bill, Jim, Chris were able to overhaul the entire system, and the 5-stand is now shooting!
- Ownership: Trap & Skeet were paid \$75 for the birds in the houses and have handed over ownership of 5-stand to RVSC.
- Pricing: \$10 per ticket (\$8 to RVSC, \$2 to JCSA). Shooters typically complete two rounds.
- Schedule: Every other Sunday @ 10 am
- Shooting Stand Sponsorship:
 - Sponsorship of stations has two parts:
 - Renewal Sponsor. Higher price, used when the stand is being overhauled and reconstructed
 - Ongoing Sponsor. Lower price, is used every year after renewal
 - Station 11 should be assigned to Firequick
- o Paul's Report:
 - Proposed November workday to thin trees, etc.
 - Will add to agenda to discuss at future meetings to set date

Treasurer Update (Chuck)

- Financial Summary: Checking: \$20k, \$25k in Savings, \$32k in Edward Jones
 - Note: Of the \$9k expenses so far, 1/3 is insurance
 - Motion made to move the \$32 in Edward Jones to CD
- Non-Member Bird Card Fee. JCSA approved RVSC to make Non-Member total fee to shoot at RVSC \$50, which means JCSA only marks cards up by \$5 and RVSC will lower card cost to JCSA by \$5 (\$30+\$5+\$15)



- At the end of 6 months RVSC must sell 60 cards through the main office for July-December.
- If we achieve that, this new price structure will become permanent from JCSA.
- Square Account:
 - We need to get Bill set up to be authorized owner of the square account
- o Open Treasury Items:
 - Board Member Insurance. Aaron: Send Chuck the JCSA insurance policy for review (May mtg).
